An archaeological evaluation was undertaken by Cotswold Archaeology in September 2015 at land off Kingsdale Court, Broadway, Worcestershire. Five trenches were excavated.

The site contained a relict ploughsoil associated with extant east/west orientated ridge and furrow. A single, shallow, post-medieval/modern pit was observed cutting the ploughsoil. No further archaeological features or deposits were revealed.

1. INTRODUCTION

- 1.1 In September 2015 Cotswold Archaeology (CA) carried out an archaeological evaluation for Rooftop Housing Group Ltd on land off Kingsdale Court, Broadway, Worcestershire (centred at NGR: SP 1028 3780; Fig. 1). The evaluation was undertaken to comply with a condition of planning permission granted by Wychavon District Council (WDC) for the construction of 13 dwellings, including a new access and associated works (WDC planning reference: W/13/01493/PN, condition 2).
- 1.2 The evaluation was carried out in accordance with a brief for archaeological evaluation (WAAS 2015) written by Mike Glyde and amended by Adrian Scruby, the former and current archaeological advisors to WDC respectively, and with a subsequent detailed *Written Scheme of Investigation* (WSI) produced by CA (2015) and approved by Adrian Scruby. The fieldwork also followed *Standard and guidance: Archaeological field evaluation* (ClfA 2014), the *Requirements and Guidelines for Archaeological Projects in Worcestershire* (WAAS 2010), the *Management of Archaeological Projects* (English Heritage 1991) and the *Management of Research Projects in the Historic Environment (MORPHE): Project Manager's Guide* (English Heritage 2006).

The site

- 1.3 The proposed development area is 0.45ha in extent and comprises agricultural land currently under pasture. It is bounded to the north and east by further agricultural fields and to the south and west by residential properties. The site lies at approximately 108m AOD. Tree coverage in the northern and southern parts of the site restricted the area suitable for trenching to approximately 0.2ha in the centre of the site.
- 1.4 The underlying bedrock geology of the area is mapped as Charmouth Mudstone Formation of the Jurassic Period with no superficial deposits being recorded (BGS 2015). The natural substrate encountered in all trenches consisted of yellow-brown clay.

2. ARCHAEOLOGICAL BACKGROUND

2.1 In line with the requirements of the Brief, a Historic Environment Record (HER) search was undertaken, in addition to reviews of public domain data and aerial photography from the mid-20th century. The most salient points from this research are summarised here.

Prehistoric

- 2.2 An unstratified Bronze Age leaf-shaped bronze sword, now housed in the British Museum, has previously been recovered from an unknown location in Broadway (WSM10946).
- Two enclosures, represented by cropmarks, are located to the north-east of the site. The furthest, located 350m away, is potentially of an Early Iron Age date (WSM10080). The other enclosure (WSM31102), located approximately 150m away within an adjacent field, is undated.
- 2.4 An archaeological evaluation undertaken approximately 700m to the north-west of the current site identified a number of potentially Iron Age features, including an enclosure and circular ditches (CA 2013).

Medieval and Post-medieval

- 2.5 The site is located approximately 400m to the north-east of the medieval core (WSM10947), and 100m to the north of the boundary of the conservation area, of Broadway. Medieval tenement plots are recorded to the north (WSM 17729; WSM 17737) and south (WSM 177730) of the High Street and along the medieval street system (WSM17733). Within the immediate vicinity of Broadway, medieval ridge and furrow earthworks survive. These are particularly concentrated to the north-east of the town (WAAS 2015), including the proposed development site where earthwork remains of east/west orientated ridge and furrow and an associated north/south aligned headland, the latter adjacent to the eastern boundary of the site,
- 2.6 The site is depicted as an orchard on Ordnance Survey (OS) maps from 1884 to 1977. The remains of an apple orchard survive within the northern and southern portions of the site.

3. AIMS AND OBJECTIVES

3.1 The objectives of the evaluation are to provide information about the archaeological resource within the site, including its presence/absence, character, extent, date, integrity, state of preservation and quality, in accordance *Standard and guidance: Archaeological field evaluation* (CIfA 2014). This information will enable WDC to identify and assess the particular significance of any heritage asset, consider the impact of the proposed development upon it, and to avoid or minimise conflict between the heritage asset's conservation and any aspect of the development proposal, in line with the *National Planning Policy Framework* (DCLG 2012).

4. METHODOLOGY

- 4.1 The fieldwork comprised the excavation of five trenches, each 20m long and 1.8m wide, in the locations shown on the attached plan (Fig. 2). Trenches 2, 3 and 5 were moved slightly to avoid an existing sewer. The trenches were set out on Ordnance Survey National Grid (NGR) co-ordinates using Leica GPS and surveyed in accordance with CA Technical Manual 4 Survey Manual.
- 4.2 All trenches were excavated by mechanical excavator equipped with a toothless grading bucket. All machine excavation was undertaken under constant archaeological supervision to the top of the first significant archaeological horizon or the natural substrate, whichever was encountered first. Where archaeological deposits were encountered they were excavated by hand in accordance with CA Technical Manual 1: Fieldwork Recording Manual.
- 4.3 Deposits were assessed for their palaeoenvironmental potential in accordance with CA Technical Manual 2: The Taking and Processing of Environmental and Other Samples from Archaeological Sites but no deposits were identified that required sampling. All artefacts recovered were processed in accordance with Technical Manual 3 Treatment of Finds Immediately after Excavation.
- 4.4 The archive and artefacts from the evaluation are currently held by CA at their offices in Kemble. Subject to the agreement of the legal landowner the artefacts will be deposited with Worcestershire County Museum, along with the site archive. A summary of information from this project, set out within Appendix C, will be entered onto the OASIS online database of archaeological projects in Britain.

5. RESULTS (FIGS 2-3)

- 5.1 This section provides an overview of the evaluation results; detailed summaries of the recorded contexts and finds are to be found in Appendices A and B.
- 5.2 The natural clay substrate was encountered in all trenches at a depth of between 0.5m and 0.6m below present ground level (bpgl). It was sealed by a c. 0.28m thick relict ploughsoil, most probably associated with the extant ridge and furrow earthworks, which was in overlain by topsoil.
- 5.3 In Trench 5 the relict ploughsoil was cut by shallow, oval pit 504. It measured approximately 1m in length, 0.8m in width and was 0.1m in depth. It contained a single clay fill, 505, from which a fragment of clay tobacco pipe stem was recovered. The relict ploughsoil (contexts 102 and 202) contained a sherd of 12th to -14th century medieval pottery alongside later, post-medieval, ceramics and building material.

6. THE FINDS

Artefactual material was hand-recovered from three deposits: relict ploughsoils and a pit fill. The recovered material dates to the medieval and post-medieval periods. The pottery has been recorded according to sherd count/weight per fabric. Quantities of the artefact types are given in Appendix B. Where possible, fabric codes are equated to the Worcestershire online ceramics database.

Pottery: Medieval

6.2 An unfeatured bodysherd of Malvernian Rock-tempered ware (TF56) (35g), recorded in relict ploughsoil 102, is dateable to the 12th to 14th centuries. Condition, in terms of edge abrasion and surface preservation, is moderate to good.

Post-medieval

6.3 Pottery dating to this period totals four sherds (151g) in very good condition, both recovered from relict ploughsoil 202. Represented fabric types are: glazed earthenware (GLEW), of mid 16th to 18th century date; and Yellow slipware (TF80), which dates to the late 17th to 18th centuries.

- Ceramic building material
- Relict ploughsoil 202 also produced a fragment of post-medieval ceramic building material in poor condition.
 - Clay tobacco pipe
- 6.5 A fragment of clay tobacco pipe stem, retrieved from fill 505 of pit 504, is of late 16th to late 19th century date.

7. DISCUSSION

7.1 No archaeological features or deposits predating the relict ploughsoil and the extant ridge and furrow were encountered during the evaluation. Such evidence suggests that either earlier archaeological remains have been removed by historic ploughing or that they were never present. The finds from the relict ploughsoil suggest that it may have been cultivated as late as the 18th century. Pit 504 had no obvious function, but clearly cut the relict ploughsoil and as it contained a clay tobacco pipe stem it may date to the use of the site as an orchard, possibly even representing a tree planting hole.


