An archaeological watching brief was undertaken by Cotswold Archaeology during groundworks associated with the development of a detached unit of bed and breakfast accommodation at The Old Brewhouse, 5-7 London Road, Cirencester, Gloucestershire.

A re-worked post-Roman 'dark earth' deposit was identified along with the remains of a wall comprising the garden boundary between properties 5 and 7. No artefactual material predating the post-medieval period was recovered.

### 1. INTRODUCTION

- In January 2009 Cotswold Archaeology (CA) carried out an archaeological watching brief for Mrs R. Scrivens at The Old Brewhouse, 5-7 London Road, Cirencester (centred on NGR: SP 0270 0197; Fig. 1). The watching brief was undertaken to fulfil a condition attached to a planning consent for a detached unit of bed and breakfast accommodation to the rear of the property (Planning ref: 07/02819/FUL). The objective of the watching brief was to record all archaeological remains exposed during the development.
- 1.2 The watching brief was carried out in accordance with a Written Scheme of Investigation (WSI) produced by CA (2009) and approved by Cotswold District Council (CDC) acting on the advice of Charles Parry, Senior Archaeological Officer, Gloucestershire County Council (GCC), the archaeological advisor to CDC. The fieldwork also followed the Standard and Guidance for an Archaeological Watching Brief issued by the Institute of Field Archaeologists (2001), the Statement of Standards and Practices Appropriate for Archaeological Fieldwork in Gloucestershire (GCC 1996) and the Management of Archaeological Projects (English Heritage 1991).

### The site

- 1.3 The site is located within the back garden of 5-7 London Road within the northern part of Cirencester. The property fronts onto London Road to the south and is bounded by Waterloo Road to the west, the Waterloo Car Park to the north and domestic properties and their associated gardens to the east (Fig. 2). The site is flat and lies at approximately 110m AOD.
- 1.4 The development area comprises an area of approximately 550m² and comprised a lawned area to the rear of the property.
- 1.5 The underlying solid geology of the area is mapped as Forest Marble of the Middle Jurassic Era overlain by limestone gravel First Terrace Deposits of the River Windrush (BGS 1998). However these deposits were not encountered during the watching brief.

### Archaeological background

- 1.6 The site falls immediately to the south of a notification area of Scheduled Ancient Monument Glos. 361 (Corinium Roman Town). However the proposed development is sited in an area of high archaeological potential. In particular, it lies within the Roman town of Corinium (insula XVI), on or adjacent to the postulated alignment of the Fosse Way and the street bounding the south-western side of the insula (Streets B and K Holbrook and Pamment Salvatore 1998, Fig. 7) (Fig. 2).
- 1.7 To the south-east (at the site of the former Gaumont Cinema) remains of a further street (Street E Holbrook and Pamment Salvatore 1998, Fig. 7) were identified together with the remains of timber buildings. These features were overlain by extensive areas of metalling (Wacher 1965, 101-2). Structural remains dating to the Romano-British period were identified during archaeological evaluations undertaken at the Woolmarket and Waterloo Car Parks, located *c*. 150m to the north-west of the site (OA 2006 and CAT 1998).
- 1.8 Archaeological evaluation within the proposed development area identified *in situ* Roman deposits (probable surfaces and wall footings) 1.25m below the present ground level (bpgl) (108.47m to 108.77m AOD). These were in turn sealed by reworked Roman demolition deposits and reworked post-Roman 'dark-earth' deposits (CA 2008).

### Methodology

- 1.9 The fieldwork followed the methodology set out within the WSI (CA 2009). An archaeologist was present during intrusive groundworks, which comprised excavation for the foundations (a reinforced concrete raft) of the proposed unit (Fig. 2).
- 1.10 Where archaeological deposits were encountered written, graphic and photographic records were compiled in accordance with CA Technical Manual 1: *Fieldwork Recording Manual* (2007).
- 1.11 The archive from the watching brief are currently held by CA at their offices in Kemble. None of the finds recovered during the watching brief will be retained and the documentary archive will be deposited with Corinium Museum. A summary of information from this project, set out within Appendix C, will be entered onto the OASIS online database of archaeological projects in Britain.

### 2. RESULTS (FIG 2)

- 2.1 The earliest deposit encountered was a post-Roman 'dark earth' deposit 302. This deposit was at least 0.13m thick and was sealed by topsoil 0.32m thick.
- 2.2 A wall footing 303 was also encountered within the northern part of the site, covered/butted by the topsoil. This wall footing represented the remains of the former garden boundary between properties 5 and 7.
- 2.3 No other features or deposits of archaeological interest were observed during groundworks and, despite visual scanning of spoil, no artefactual material pre-dating the post-medieval period was recovered.

### The Finds

- 2.4 Quantities of pottery, glass and clay tobacco pipe were recovered from topsoil 301 and dark earth deposit 302 (Appendix B).
- 2.5 A total of 10 sherds of post-medieval pottery (154g) was recovered from layers 301 and 302. Types present include unglazed flowerpot type earthenwares, white china, mocha ware, creamware and English stoneware. All are typical of 19th-century or later dating.
- 2.6 Post-medieval or modern bottle glass was recovered from both layers. Two pieces of clay tobacco pipe stem were recovered from the 'dark earth' deposit 302.
- 2.7 Due to the post-medieval date of the finds and the disturbed nature of the contexts they were found in, the artefactual material is not deemed to be of archaeological significance and will not be retained.

### 3. DISCUSSION

3.1 Excavation to the maximum depth of impact (0.45m bpgl) encountered a post-Roman 'dark earth' deposit. 'Dark earth' deposits were also identified during the evaluation and finds recovered from these deposits indicated that they had been reworked (CA 2009). The *in situ* Roman deposits identified during the evaluation (at an average depth of 1.20m bpgl) were not encountered during the groundworks.
