1. INTRODUCTION

1.1 General

This report presents the results of a watching brief undertaken by CFA Archaeology Ltd (CFA) between November 2011 and January 2012 at Pencaitland Parish Church, Pencaitland, East Lothian (NGR: NT 4432 6901) (Fig. 1), during the installation of new drainage trenches, lighting columns and the regeneration of footpaths in and to the west of the churchyard.

The work was conducted in accordance with a Written Scheme of Investigation (WSI) dated 1st November 2011, produced by CFA on behalf of Chalmers & Co. The WSI was designed to fulfil the requirements of the East Lothian Council Archaeology Service (ELCAS). It consisted of archaeological monitoring during the excavation of trenches for drainage, groundbreaking works associated with the upgrading of footpaths, minor surface alterations in the churchyard, and the installation of electricity cabling and lighting columns. During these excavations, human remains were expected to be retrieved and reburied.

1.2 Background

Pencaitland Parish Church and Burial Ground (RCAHMS No. NT46NW 16) is situated between the old settlements of Easter and Wester Pencaitland. The Church is A Listed (HB num. 18933) and is still in use as an ecclesiastical building.

The church dates from the late 12th to 13th century, with a complicated history of major alterations with a number of blocked openings visible: the pre-reformation nave was probably built on medieval foundations, the addition of the Winton Aisle, the addition of the west bell tower and the Saltoun Aisle was in the 17th century, and alterations to the church grounds took place in the 19th century. The main church building is surrounded by its associated burial-ground, and may have been the site of a pre-Reformation seminary: the Pre-reformation church belonged to the monks of Dryburgh Abbey. The graveyard contains a selection of fine gravestones, including ornately carved table-tombs, and there are a number of wall monuments. The gate house is probably 18th century, and two Offertory Houses are probably 18th and 19th century.

1.3 Objectives

The objectives of the watching brief were:

- To conduct an appropriate programme of archaeological investigation (Monitored Strip) to monitor all ground breaking works described above within the development area.
- Tto mitigate the effects of construction on any archaeological deposits or features identified through excavation and recording; to recover human remains and re-inter them appropriately; and produce a report on them.

2. WORKING METHODS

2.1 General

CFA Archaeology Ltd follows the Institute for Archaeologists' Code of Conduct, Standards and Guidance for Archaeological Fieldwork. Recording of all elements followed established CFA methods, as detailed in the approved WSI.

2.2 Archaeological Watching Brief

The surfaces of the paths were excavated by a tracked mini-digger with a smooth-bladed ditching bucket or by hand under constant archaeological supervision. Human remains were identified and recovered for reburial, in line with Historic Scotland Operational Policy Paper 5, *The Treatment of Human Remains in Archaeology*. Articulated human remains, high concentrations of human skeletal material, and substantial human cranial elements were recorded as Skeletal Clusters, and reburied on site as close to their original positions as possible (Fig. 3). Charnel – previously disturbed and disarticulated human remains – was recovered and reburied in caches in recorded locations (Fig. 4).

Several headstones, family plot boundary markers, and elements of monumental masonry were uncovered during the course of excavations. These were recorded and left in situ or replaced close to their original position as possible, after consultation with ELCAS. Architectural features near the North and West gates of the churchyard were recorded.

All work was recorded using standard CFA recording forms, plans and digital photography.

3. ARCHAEOLOGICAL RESULTS

Numbers in bold in the following text refer to contexts, a full list of which is contained in Appendix 1. Numbers in square brackets refer to the Skeletal Clusters recorded, which are more fully described in Appendix 3.

Drainage and footpath trenches were excavated in the woodland area to the west of the churchyard proper, around the church building itself, and in the eastern flank of the burial grounds. Lighting cable trenches were dug along the north and east of the church building. In addition several areas of the churchyard were landscaped (Fig. 2). All of these works were monitored

3.1 Drainage, Lighting and Footpath Trenches to West and North of the Church Building

Drainage trenches were excavated from the burn to the south-west of the churchyard north-eastwards to the West Gate, and eastwards to the SW corner of the main church building (Trench 1)(Fig. 2). A new manhole was installed just E of the West Gate, and Trench 2 was excavated from this point eastwards along the north flank of the church building.

The drainage trenches were 0.4m wide and varied from 1.7m deep at the west to 0.6m deep in the east. Footpath trenches were a minimum of 1.6m wide and dug to a depth of at least 0.2m below the existing ground surface. Electric cable trenches were also excavated along the length of Trench 2 to a minimum of 0.4m below the existing surface level

Nineteen skeletal clusters were identified and subsequently reburied in Trench 1, [3], [6]-[17], [20], and [55]-[58] (Fig. 3). A stone drain, running from the West Gate SE to the western face of the church building, was exposed along the footpath trench.

Twenty-seven skeletal clusters were identified and reburied along Trench 2. High levels of charnel – disturbed human remains found in top- and sub-soils – encountered here were due to the antiquity of this section of the graveyard and the disturbance from previously inserted stone and slate drains installed here and encountered during the excavations. The stone drain in Trench 1 forms a junction with the drain in Trench 2 and runs E to the north transept's NW corner.

Trench 2 was extended southwards to the north face of the western aisle. This uncovered Clusters [54] and [64], the latter a neonate in situ burial furnished with shroud pins at head and feet, lying just north of the north church building wall.

Also revealed were 4 large dressed sandstone slabs (201-204, Fig. 2) lying horizontally in the corner of the north transept and main church building in front of the wall's inset memorial stone (Fig. 5). These rectangular slabs were oriented E-W and laid in a rough square formation; all were carefully cut and dressed with their blank smooth face upright, except slab 204 which had a rough face upwards and may have been upside-down. Slab 201 was 0.79m x 0.61m and was cut or damaged on its south edge. Slab 202, measuring 0.77m x 0.46m, was also cut at its SE corner, perhaps from the same episode of disturbance. Slab 203 was undamaged, and was

0.92 x 0.43m in size. Slab **204** had a roughly finished face and was cracked into two pieces; it measured 0.84 x 0.77m. These stones were cleaned, photographed, and lifted, to be replaced by conservation masons at a slightly lower level.

The excavation of Trenches 1, 2 and 13 in the area of the cemetery West Gate revealed some structural remains related to the gate, its walls and the buildings associated with it. Rubble between the gate posts (101) did not appear to be architecturally coherent, and was disturbed by existing stone drains in the area. Immediately south of the northern building, however, a previous courtyard surface was preserved (102). This was an area, 2m x 1.2m, of mortared slate paving, laid on a thin foundation of mid orange sand-lime mortar which also bonded the paving slabs (Fig. 13). Surface 102 abutted a possible cross wall (103) running N-S (Fig. 14), probably representing the continuation of the earlier boundary wall (see Fig. 10), predating the modification to the West Gate area.

Trench 13, a footpath trench through the wooded area to the west of the West Gate, was machine-excavated and extended approximately 25m in an S-bend from the West gate to the road. Immediately west of the West Gate two stone features running NW-SE (1304, 1305) were partially uncovered and identified as probable drains. Throughout most of the path 0.2-0.4m of loose dark topsoil overlay a yellowish-brown (1301) or greyish (1303) sandy silt buried horizon above a compact clayey deposit with a high density of angular stones (1302). No deposits of archaeological significance were found along Trench 13.

Several others areas were subject to limited ground-breaking works (Fig. 2). In Trench 16 a further skeletal cluster was revealed, cranial fragments [63], and reburied. Trench 17 exposed a weathered headstone which was not further disturbed. Other areas did not reveal deposits or structures of archaeological significance beyond small quantities of charnel.

3.2 Drainage, Lighting and Footpath Trenches to East of Church Building

Trench 3 ran southwards from the existing small building at the North Gate along the eastern flank of the church building. Footpath, drainage and electricity cable trenches were dug along Trench 3. 12 Skeletal Clusters were identified ([43]-[47], [49]-[51]) including a fully-articulated child inhumation [51] (Fig.6), lying at 0.42m below the existing surface.

The far north end of Trench 3 exposed the foundations and footings (302) of the small North Gate building which may overlie the previous gateway and boundary wall (see below). These footings extended 0.6m south of the building's edge at its SE corner and were composed of uncoursed, sub-angular medium stone rubble faced on its south side with a large angular cut stone block.

Further south in Trench 3, two upstanding headstone footings were exposed in the new footpath trench (Fig. 7). The southerly slab (303), exposed for a maximum of 0.25m into the trench, was 0.98m long and made of white limestone with traces of an upstanding headstone slot. The northerly slab (304) was a laid flat carved reddish sandstone headstone, 0.94m long. It may have been a headstone flattened during

previous footpath construction, or reused as a headstone footing. Both were left in situ.

High levels of charnel in Trench 3 were attributable at least in part to previous disturbance from the existing stone and slate-lined ceramic pipe drains running roughly NE-SW, which had cut through earlier graves.

Trenches 4 and 5 were for the most part excavated by hand and ran eastwards from the church building downpipes into the main drainage channel. Some charnel was encountered here and reburied but no other remains of archaeological significance were encountered.

3.3 Footpath Trenches to the South of Church Building

Trench 10 was excavated in a loop from the SE corner of the church building and its eastern doorway SW, west and north to the west door and the east end of Trench 1. No drainage or lighting trenches were required here; the footpath trench was dug to a depth of 0.2m. One Skeletal Cluster [62] was identified and reburied (Fig. 3).

A group of 3 rectangular, dressed stone slabs was revealed in Trench 10 (Fig. 8), one with a carved decorative pedestal base or ornament at c.0.15m below the existing footpath surface. Stone **1001** measured 0.70m x 0.37m, with a broken NE end, and was oriented NE-SW. Slab **1002** was 0.80m x 0.38m, broken at its south end and sitting on **1002**'s north end was a reddish carved sandstone ornament like a column base (**1004**). Slab **1003** was 0.97m x 0.36m, and its north end extended into the northern edge-of-excavation. These slabs were photographed and reburied in situ with a capping of fine clean sand below the Type 1 footpath bedding.

A small round-headed headstone (1005) was partially revealed in the N-S running portion of Trench 10, 3.50m south of the SE corner of the church tower west door (Fig. 2). It was standing upright, and was decorated with a cross in relief, deeply-carved, on its west-facing surface. This headstone was cleaned, photographed and left in situ.

Trench 11 was excavated southwards from Trench 10 and small quantities of charnel were recovered and reburied in a cache (Fig. 4).

Two test trenches, Test Trench 1 (TT1) and Test Trench 2 (TT2), were excavated against the south wall of the main church building to asses the deposits here. Individual [48] was exposed in the NW corner of TT1 at 0.4m below the existing surface, an articulated in situ infant or neonate inhumation. Excavation ceased at this point and the remains were reburied.

TT2 was excavated to a depth of 0.4m and the charnel encountered was reburied immediately in the test pit itself.

3.4 Footpath Trenches in the Eastern Graveyard and the North Gate Area

Trenches 6, 7, 8, and 9 were excavated in the eastern area of the church grounds. In addition Trench 8 and the northern extent of Trench 3 were considerably expanded,

exposing structural elements related to a previous cemetery entrance/boundary. Excavations in Trench 6 also revealed structural elements near the refurbished Carriage House complex.

Trench 6 was excavated eastwards for footpath refurbishment to a depth of 0.2m below the surface and for an electricity cable 0.4-0.6m deep in a c.0.4m wide strip. At the NW corner of the existing Carriage House these trenches exposed Wall **601**, and, further eastwards, possible rubble wall foundations (**604**, **606**) and red sandstone paving (**605**) (Fig. 9). Wall **601** ran roughly N-S, was 0.5m wide and was exposed for a length of 1.6m across the trench. Composed of angular stone blocks bonded in sand-lime mortar, it was preserved to at least 4-5 courses high (1.12m). Wall **601** continues the line of the cemetery boundary wall on the west end of the Carriage House complex and represents the remains of the cemetery's earlier boundary as shown on the 1853 6-inch First edition OS map (Fig. 10). These boundaries changed by 1895 as they do not appear on the 2nd Edition OS map of that date.

East of Wall **601**, a stretch of structural remains were exposed along the north flank of the Carriage House buildings. Preserved at approximately 0.4m below the existing surface, these remains were exposed only in the narrow cable trench. They consisted of possible rubble wall or courtyard-surface footings (**604**), running N-S and measuring up to 2.2m wide, which defined the east and west extents of a 2m wide stretch of red sandstone paving (**605**). These may relate to a courtyard area between the Carriage House complex and the building to the north visible on the 1853 OS map (Fig. 10).

Trench 7 was excavated NW to the junction with Trenches 3 and 6. Excavation here revealed a carved stone headstone footing (701) (Fig. 11). Exposed c.0.18m below the existing surface, (701) was an in situ carved rectangular white stone slab, 0.84m x 0.33m, with an internal rectangular recessed slot for a headstone; it was cleaned, photographed, and left in position. A plot boundary marker stone, marked 'H', 0.15m x 0.15m x 0.21m, was also exposed, photographed, moved off the footpath line and re-set in the surrounding turf.

Trench 9 was excavated northwards from the NE corner of the existing building, and revealed, from 8.1m north of the cemetery boundary wall, a layer of cobble rubble (901), projecting 0.54m into the trench along its E edge. This was perhaps previous footpath foundations, (901) and was found to run along the length of the trench northwards to its junction with Trench 8. At 13.7m north of the boundary wall, a plot marker stone inscribed 'A. WILSON' was exposed and replaced at the new footpath edge. No charnel or skeletal clusters were recovered in this trench.

Trench 8 was dug westwards from Trench 9. Exposed in this trench were deposits of large angular loose stone rubble (810), perhaps the remains of demolished boundary walls, and, in the North Gate Area, a series of mortared walls (801)-(809) which appear to be associated with a previous cemetery boundary wall and narrower churchyard entrance (Fig. 12).

Wall (801) ran NW-SE, exposed for a length of 5.2m, and was built of lime-mortar bonded sub-angular sandstone blocks up to 0.58m wide. This and other walls were

exposed to depths of only 0.1-0.2m. It was abutted on its north face by Wall **802**, on its south face by smaller Wall **803**, and was truncated at its western end by drains.

Wall (801) may have terminated near the point of the modern drains to form, with 809, the narrower earlier entrance into the graveyard. Wall 809, similarly constructed, continues on the same line as 801 NE to the north gateway building and underlies it. Wall 808 underlies the SE corner of this building and represents either its foundations or to the corner of a previous boundary wall (suggested in the 1853 1st Edition OS map) which is otherwise not archaeologically attested. Wall 802, built of angular stone blocks bonded in yellowish lime mortar, curves off Wall 801 to form a bonded return with Wall 807. Together, 807, 802 and Walls 801/809 are likely to have formed a bowed gateway into the burial grounds.

Wall (804), truncated and badly preserved, formed a return from Wall (801) to the SW. It may be the remaining part of foundations of a small structure just inside the gateway, along with Walls (803), (805) and (806) which are similarly constructed and together forms a small 1.6m x 1.4m chamber. Walls (803), (805) and (806), one course wide and high of angular sandstone, were also truncated by later clay drainage pipes. No surfaces associated with these walls were encountered.

3.5 Discussion

On the 1855 Ordnance Survey (OS) 6 inch map, the building now referred to as the Carriage House is labelled 'Manse' and a rectangular building lies to its north, aligned N-S and lying within what is now the eastern part of the churchyard, labelled 'College'; this building no longer exists. A smaller building lies to the NE off its NE corner, adjacent to the road. A small square building is present at the West Gate. The boundary wall of the churchyard is also different in layout to the existing: the eastern boundary is much closer to the church, springing from the NW corner of the 'Manse' (Carriage House) complex and continuing north towards the North Gate. This boundary wall appears to correspond to Wall **601** recorded during the watching brief.

The boundary wall corresponding to **601** and the building marked as 'College' on the First Edition map no longer survive on the 1894 map. The eastern part of the churchyard is now similar in layout to the existing. The small building at the North Gate and the group of buildings at the West Gate, replacing the single small square building from previous, are depicted. There is little change on the 1907 OS map.

It is possible that the wall remains recorded as 102 are the foundations of the slightly earlier square building depicted on the 1855 map. It is not clear that the remains recorded at the North Gate relate to any structures depicted on the Ordnance Survey maps; however, the gate seems to have always been in this approximate location and so the structures probably relate to the gate or the northern end of the 'College' complex. The cobbles (901) running up the eastern edge of the churchyard likely relate to an earlier phase of path/access track to the manse, which appears to have always been in this approximate locaton.

4. CONCLUSION

A watching brief was carried out during ground works for the upgrading of footpaths and installation of drainage and footpath lighting in the grounds of Pencaitland Parish Church cemetery. The human remains encountered during these works, both in situ articulated burials and re-deposited charnel, were retrieved and reburied either as close to their original positions as possible or in charnel caches whose locations were recorded. Exposed grave slabs, footings and boundary markers were cleaned and photographed. Architectural remains relating to a previous churchyard entrance and a former boundary wall were recorded.

The project archive, comprising all CFA record sheets, maps and reports, will be deposited with the National Monuments Record of Scotland (NMRS) and copies of reports will be lodged with the East Lothian Council Sites and Monuments Record.

A summary statement of the results of this watching brief will be submitted for publication in *Discovery and Excavation in Scotland* (Appendix 3) and an online OASIS form will be completed.






Fig. 5 Memorial slabs 201-204

Fig. 7 Headstone footings 303 (right) and 304 (left)




Fig. 8 Dressed slabs 1001 (right), 1003 (left) and 1002 (middle)








Fig. 13 Mortared slate surface 102, West Gate
