11 CULTURAL HERITAGE

11.1 EXECUTIVE SUMMARY

- 11.1.1 This chapter considers the potential impacts on archaeology and built heritage interests of the construction and operation of the proposed development. The assessment has been undertaken by CFA Archaeology Ltd (CFA), taking into account comments and information provided by Historic Scotland and the Fife Council Archaeologist.
- 11.1.2 The assessment identifies and evaluates any archaeological sites present within the proposed development area through examination of desk-based sources and field reconnaissance and identifies any key receptors within 10 km of the proposed development that could have their settings affected.
- 11.1.3 The proposed development area has been completely sterilised by 20th century opencast coal mining works (Figure 11-1). The former mine workings have subsequently been reinstated, landscaped and restored to agricultural use. The few historic farmsteads and 19th century deep mines that were formerly present have all been removed by opencast operations and the site has no archaeological potential.
- 11.1.4 There would be no direct impacts on any sites or features of cultural heritage interest arising from the construction of the proposed development.
- 11.1.5 Twenty-nine Scheduled Monuments, 19 Category A Listed Buildings, 109 Category B Listed Buildings, 55 C(S) Listed Buildings, six Inventory Gardens and Designed Landscapes and three Conservation Areas were identified within 10 km of the proposed development that would have theoretical intervisibility with the proposed development (Figure 11-2). No significant impacts on the setting of these features are predicted.
- 11.1.6 The cumulative impact of the proposed development in combination with other wind developments in the vicinity is not considered to be significant.

11.2 INTRODUCTION

- 11.2.1 This chapter considers the potential impacts of the proposed development on cultural heritage interests. The chapter details the results of a desk-based assessment and site visit. The cultural heritage assessment was undertaken by CFA Archaeology Ltd, using information provided by Historic Scotland and the Fife Council Archaeologist.
- 11.2.2 This assessment was conducted in accordance with the Institute for Archaeologist Code of Conduct (IfA 2010), and Standard and Guidance for Archaeological Desk-based Assessment (IfA 2009).
- 11.2.3 The assessment evaluates the impacts of the proposed wind development on:
 - Scheduled Monuments and other archaeological features;
 - Listed Buildings and other buildings of historic townships; and
 - Gardens and Designed Landscapes and other important historic landscapes.
- 11.2.4 The assessment was conducted with reference to the relevant statutory and planning framework for cultural heritage as noted in Section 11.3.

11.3 LEGISLATIVE AND PLANNING CONTEXT

11.3.1 Scotland's historic environment contributes to the Scottish Government's strategic objectives and to the National Performance Framework. The Scottish Historic Environment

Policy (SHEP) document sets out Scottish Minister's policies for the historic environment, and provides policy direction for Historic Scotland and a framework that informs the day-to-day work of a range of organisations that have a role and interest in managing the historic environment. Through the SHEP, Scottish Minister's are determined to achieve three outcomes for Scotland's historic environment:

- that the historic environment is cared for, protected and enhanced for the benefit of our own and future generations;
- to secure greater economic benefits from the historic environment; and
- that the people of Scotland and visitors to our country value, understand and enjoy the historic environment.
- 11.3.2 Cultural heritage assets include sites with statutory and non-statutory designations as set out in SPP.
- 11.3.3 Sites with statutory designations include:
 - Scheduled Monuments;
 - Listed Buildings;
 - Conservation Areas; and
 - Designated Shipwrecks.
- 11.3.4 Sites without non-statutory designations include:
 - World Heritage Sites;
 - Inventory Gardens and Designed Landscapes;
 - Historic Battlefields; and
 - Other Historic Environment Interests.
- 11.3.5 Those assets relevant to this assessment are Scheduled Monuments, Listed Buildings, Conservation Areas and Gardens and Designed Landscapes.

Sites with Statutory Designation

Scheduled Monuments

11.3.6 Under the Ancient Monuments and Archaeological Areas Act 1979 (1979 Act), the Scottish Ministers are required to compile and maintain a Schedule of monuments considered to be of national importance. The statutory consent of the Scottish Ministers is required before any works are carried out which would have the effect of demolishing, destroying, damaging, removing, repairing, altering, adding to, flooding or covering up a Scheduled Monument. In addition, impacts of proposed development works upon the setting of a Scheduled Monument form an important consideration in the granting or refusal of planning consent to conduct development works. Further information on development control procedures relating to Scheduled Monuments is provided in SHEP (July 2009), SPP (February 2010) and Planning Advice Note 42, Archaeology (PAN 42).

Listed Buildings

11.3.7 Under the Planning (Listed Buildings and Conservation Areas) (Scotland) Act 1997 (1997 Act), the Scottish Ministers are required to compile a list of buildings of special architectural or historic interest. Such buildings are classified into Categories A, B and C(S), in decreasing order of importance. Planning authorities and the Scottish Ministers are required to have special regard for the desirability of preserving Listed Buildings and

their settings and any features of special architectural or historic importance they possess. Scottish Government policy and guidance is also provided in SHEP and SPP.

Conservation Areas

11.3.8 Under the Planning (Listed Buildings and Conservation Areas) (Scotland) Act 1997 (1997 Act), areas of special architectural or historic interest can be designated by local authorities as Conservation Areas, the character or appearance of which it is desirable to preserve or enhance. Planning authorities are required to consider planning applications affecting the appearance, character or setting of Conservation Areas. Scottish Government policy and guidance is also provided in SHEP and SPP.

Sites with Non-Statutory Designations

Gardens and Designed Landscapes

11.3.9 The impact of a development on a designated Garden or Designed Landscape listed in 'An Inventory of Gardens and Designed Landscapes in Scotland or its Supplements' (Inventory; published by Historic Scotland) is a material consideration in the determination of a planning application, although the designation is non-statutory in effect. Under the provisions of the Town and Country Planning (Development Management Procedure) (Scotland) Regulations 2008 (1998 Regulations), planning authorities must consult Historic Scotland on any development that may affect a site contained in the Inventory. Scottish Government policy and guidance is also provided in SHEP and SPP.

Other Historic Environment Interests

11.3.10 There is a range of other non-designated archaeological sites, monuments and areas of historic interest, including battlefields, historic landscapes, other gardens and designed landscapes, woodlands and routes such as drove roads that do not have statutory protection. Sites without statutory protection are curated by the local planning authority and SPP and PAN 42 provide national planning policy guidance and advice on the treatment of such assets.

Regional and Local Planning Policy Guidance

11.3.11 The following sections set out the relevant planning policies covering the Local Authority area. Current Regional and Local planning guidance is provided in the Fife Structure Plan 2006-2026 (approved 2009) and the Cowdenbeath Area Local Plan (approved 2006).

Structure Plan

- 11.3.12 Paragraph 4.11 of the Structure Plan states that it is important to protect the archaeological heritage of Fife, particularly where it is of national and regional importance, from the adverse effects of development. Local Plan policies provide protection for the built and historic environments and for archaeology.
- 11.3.13 Policy Env5 of the Structure Plan states that the character, appearance and setting of designated built or cultural heritage sites will be protected from harmful development. Local Plan policies will provide protection for the built and historic environments and for archaeology.

Local Plan

11.3.14 Policy BE11 states that development proposals affecting listed buildings and their settings should not detract from those settings and will be required to conform to the highest design standards, including siting, materials, landscaping and boundary enclosures.

- 11.3.15 Under Policy BE13 any site which in the lifetime of the Plan is assessed as worthy of entry into 'An Inventory of Gardens and Designed Landscapes in Scotland' will be protected from development which would adversely affect its character. Features which have led to its designation will be safeguarded.
- 11.3.16 Through Policy BE14 development which would adversely affect Scheduled Ancient Monuments or sites recorded on the Non-Statutory List of Sites and Monuments will not be permitted unless exceptional circumstances are demonstrated. Elsewhere the preservation *in-situ* of Archaeological Sites and Area of Regional Importance, as well as local archaeological sites will be balanced against the benefits of the proposed development.
- 11.3.17 Policy BE16 states that provision will require to be made for archaeological investigation and recording during any development which uncovers as yet unidentified remains considered by Fife Council to be of regional importance. Fife Council will seek developer funding by means of formal agreement to support the cost of all archaeological investigation and recording work.

11.4 METHODOLOGY

Study Area Description

- 11.4.1 The cultural heritage study area consists of two parts:
 - The proposed development site within the redline boundary shown on Figure 11-1, which covers an area of approximately 90 ha, within which it is proposed to erect the turbines. This area consists entirely of a former opencast coal mine that has now been restored as farmland and small woodlands.
 - A wider study area, extending to 10 km from the proposed development area boundary provided the study area for the identification of sites with statutory protection (and those with national and regional non-statutory designations) whose settings may be affected by the proposed development.
- 11.4.2 Figure 11-1 depicts the locations of former archaeological sites and monuments identified by the cultural heritage study within the proposed development site red-line boundary. A gazetteer of these sites is provided in Appendix 11.1. All of the previously recorded sites have been lost to opencast coal mining operations carried out between 1982 and 1992.
- 11.4.3 Figure 11-2 shows the proposed development in its wider landscape setting together with the ZTV and the locations of key cultural heritage receptors within 10 km and which would have theoretical views of the turbines. Appendix 11.2 contains a list of those key receptors within 5 km of the proposed development and provides a summary assessment of the predicted indirect visual impacts on their settings, on a site by site basis. Appendix 11.3 provides a list of the key cultural heritage receptors within 5-10 km of the proposed development.

Consultation

11.4.4 A scoping response was received from Fife Council in June 2010, which included correspondence from Historic Scotland. A summary of the scoping response which relates to cultural heritage is provided in Section 11.5, Table 11.9.

Baseline Characterisation

Data Collection

11.4.5 Up-to-date information was obtained from appropriate sources on the locations of cultural heritage sites with statutory protection and non-statutory designations either within or in

the vicinity of the proposed development area. Details of the locations and extents of Scheduled Monuments, Listed Buildings, Garden and Designed Landscapes in GIS were downloaded from Historic Scotland's Spatial Data Warehouse (Historic Scotland, 2011).

- 11.4.6 Information on the character and condition of known archaeological sites and features within the proposed development area was obtained from the National Monuments Record of Scotland (NMRS) and from the Council's Sites and Monuments Records (SMR).
- 11.4.7 The Coal Authority's Mine Completion Plan Keirsbeath 010363 (2009) provided information on the final extent of the opencast works undertaken between 1982 and 1992.
- 11.4.8 Bibliographic references were consulted to provide background and historical information relevant to the development site.
- 11.4.9 The Historic Land-Use Assessment Map for Scotland (RCAHMS 2011) maintained by the RCAHMS, was consulted for information on the historic land use character of the proposed development area.
- 11.4.10 The Scottish Palaeoenvironmental Database (Coles et al, 1998), which records the distribution of known sites across Scotland, was consulted for information on palaeoenvironmental data within or adjacent to the proposed development area.

Field visits

11.4.11 The desk-based assessment indicated that the proposed development area has been almost completely sterilised by 20th century opencast coal mining works and therefore it was considered that there was no requirement for a field visit to be carried out. The extent of the former mine works is shown on Figure 11-1.

Assessing Significance

- 11.4.12 The impacts of the proposed development on cultural heritage assets are assessed on the basis of their type (direct physical impacts caused by construction operations; and indirect impacts on the settings of heritage assets, including, where appropriate, cumulative impacts) and their nature (beneficial, neutral or adverse). The assessment takes into account the sensitivity of the receptor and the magnitude of predicted impact. Mitigation measures designed to prevent, reduce or offset adverse impacts are proposed where relevant and residual impacts are assessed taking into account the likely effectiveness of the mitigation.
- 11.4.13 The assessment of sensitivity or archaeological and heritage assets reflects the relative weight which statute and policy attach to them, principally as published in SPP and SHEP. Table 11.1 summarises the relative sensitivity of the cultural heritage assets relevant to this assessment.

Assessment of Direct Impacts

11.4.14 Criteria for assessing magnitude of direct impacts, which measures the degree of change to the baseline condition of a feature that would result from the construction of one or more elements of the proposed development, are classified in Table 11.2.

11.4.15 The sensitivity of the receptor and the magnitude of the predicted impact are then used to inform the professional judgement of the likely significance of the direct impact. Table 11.3 summarises the criteria for assigning significance of a direct impact. Major and moderate direct impacts are considered significant in terms of the EIA regulations.

Identification of External Receptors and Characterisation of their Setting

11.4.16 The setting of a heritage site, feature or area is defined as "*the immediate and extended environment that is part of, or contributes to, its significance and distinctive character*" (International Council on Monuments and Sites (ICOMOS) 2005). Beyond the physical and

visual aspects, the setting includes interaction with the natural environment; past or present social or spiritual practices, customs, traditional knowledge, use or activities and other forms of intangible cultural heritage aspects that created and form the space as well as the current and dynamic cultural, social and economic context. In Historic Scotland's recently issued guidance document - Managing Change in the Historic Environment: Setting (2010) - it is stated that "setting can be thought of as the way in which a historic structure's surroundings contribute to how it is experienced, understood and appreciated".

- 11.4.17 Current Historic Scotland guidance (2010) notes that the setting of a receptor could be affected by the introduction of new development into its surroundings, even if that new development will not be directly visible from the receptor. The setting of a site often extends beyond the property boundary, or 'curtilage', of an individual historic asset into a broader landscape context and can include other, less tangible factors.
- 11.4.18 Details of previously recorded cultural heritage sites, monuments and landscape features with statutory and non-statutory designations, undesignated archaeological sites of likely national importance, within the landscape surrounding the proposed wind development area were obtained. A Zone of Theoretical Visibility (ZTV) map, generated for the proposed development, was used to identify those cultural heritage receptors within 10 km of the proposed development from where there is theoretical intervisibility with one or more wind turbines. It is judged that beyond 10 km the proposed development would not, in general, significantly affect the settings of heritage assets; the proposed development being seen only at distance, as part of the wider landscape.
- 11.4.19 The baseline setting of each relevant receptor or related group of receptors was then characterised on a case-by-case basis. Characterisation of the setting of a receptor was based upon its properties and location and took into account the factors identified in guidance issued by Historic Scotland (2010). The baseline setting of each receptor was characterised principally in terms of:
 - archaeological / historical context of the receptor;
 - current landscape and visual surroundings of the receptor; and
 - social value (actual or potential) of the receptor as a recreational / leisure or educational resource.

Assessment of Impacts on Setting

- 11.4.20 For each receptor, where a potential impact on setting has been identified, the assessment of possible impacts has followed a four-stage approach:
 - Identification of the characteristics of setting of the receptor (see above);
 - Assessment of the sensitivity of that setting;
 - Identification of how the presence of the proposed development will affect that setting (magnitude of impact); and
 - Assessment of the significance of impact.

Criteria for Assessing Sensitivity of Setting

- 11.4.21 Sensitivity of setting has been assessed by considering two factors:
 - The relative weight which statute and policy attach to the receptor and its setting; and
 - The degree to which the baseline setting contributes to the understanding and / or appreciation, and hence value, of the receptor.

CHAPTER 11 CULTURAL HERITAGE

- 11.4.22 The relative weight that statute and policy attach to the receptor and its setting is determined using the sensitivity of archaeological and heritage assets set out in Table 11.1. Where individual designated receptors are present within larger designated areas (e.g. Listed Buildings within a Conservation Area); the sensitivity is stated as the higher of the two designations.
- 11.4.23 The degree to which the baseline setting contributes to the understanding and / or appreciation of the receptor has been assessed according to the criteria set out in Table 11.4.

11.4.24 These two criteria (sensitivity of receptor and contribution to setting) are combined to assess the overall sensitivity of a setting, as set out in Table 11.5.

Identification of Magnitude of Impact on Setting

11.4.25 Where it was established that the setting of a receptor is such that there is no potential for it to be affected by the presence of the wind development, the receptor has not been considered further in the assessment. For the remaining sites, the magnitude of impact on setting has been assessed according to the thresholds in Table 11.6.

Assessment of Impact Significance

11.4.26 The significance of an impact on setting depends on both the magnitude of the impact and the sensitivity of the setting of a receptor. Table 11.7 presents a matrix that has been used to inform the assessment in combination with professional judgement.

Significance Criteria

11.4.27 The significance of impact is classified as major, moderate, minor or negligible, as defined in Table 11.8. Major and moderate impacts are considered significant in accordance with the EIA Regulations.

11.6 BASELINE CONDITIONS

- 11.6.1 The NMRS records three former cultural heritage sites present within the proposed development area. These sites have, however, been lost to recent opencast mining operations (1982-1992). Appendix 11.1 provides summary gazetteer information on the former character of each site.
- 11.6.2 Numbers in brackets, in the following sections, refer to site numbers identified on Figure 11-1 and in Appendix 11.1.

Cultural Heritage Assets within the Proposed Development Area

- 11.6.3 There are no Scheduled Monuments or Listed Buildings within the proposed development area and no part of the proposed development area lies within a Conservation Area or Inventory status Garden and Designed Landscape.
- 11.6.4 The NMRS and SMR contain records for two former farmsteads (1 and 3) and a former colliery (2).
- 11.6.5 Examination of historical OS maps (1856) shows that there were at that time a number of farms in the area (Keirsbeath, Nether Beath, Malcolm's Beath (*in ruins*), Halbeath House, Crossgates) with coal mining pits also present in the centre of the proposed development area associated with the former Cuttlehill Colliery (2). The landscape was divided into enclosed polygonal fields and a road ran west to east from Halbeath to Crossgates. A sandstone quarry formerly stood on the north side of this road, south of Keirsbeath Farm.
- 11.6.6 Examination of aerial photographs provided no new information on the development area in additional to that recorded elsewhere.
- 11.6.7 Documentary research provided some background information on agricultural activities and the 19th century mining activity in the area.
- 11.6.8 The Scottish Palaeoenvironmental Database (SPAD) provided no information relevant to the proposed development area.
- 11.6.9 The Historic Landscape Assessment Map (HLAMap) records that the development area mostly comprises restored agricultural land dating from the 20th century (reinstated following opencast coal mining operations) with small areas of new woodland plantation.

Character of the Cultural Heritage

11.6.10 Those sites and features that have been recorded within the proposed development area are associated with post medieval farming (1 and 3) and 19th century mining (2). Descriptions are provided in Appendix 11.1 and the sites are discussed thematically below.

Prehistoric and Early Historic Sites

11.6.11 There are no records of any prehistoric or early historic sites within or immediately adjoining the proposed development area. There is, however, a record of a possible Neolithic Mortuary Enclosure (NT18NW 25), visible as cropmarks on aerial photographs, to the west of the motorway at Deanpark and undated flints (NT19SW 6) have been recovered from an area to the north, at Dalbeath.

Medieval and Later Remains

Farmsteads and Field Systems

11.6.12 There are records in the NMRS of two farmsteads of post medieval date (1 and 3), formerly present within the development area. Keirsbeath (1) and Netherbeath (3) are both depicted on the OS 1st Edition maps (1854) but are also shown on Roy's map (1747-55) and in Blaeu's Atlas (1654) showing that these farmsteads have their origins in at least the late medieval period and may have been much earlier. Roy's map also shows that the low ground south of Hill of Beath and within the proposed development area was already cultivated farmland by the mid-18th century. None of these former sites survive today due to post opencast mining restoration.

Industrial Activity

11.6.13 The Statistical Accounts (1794-97 and 1845) record that coal mining in the Parish of Dunfermline extends back to at least the 13th century (Account of 1834-45; vol.9), although at that time this was restricted to exploitation by the monks of Dunfermline Abbey and was not to include resources on arable farmland. In the late 18th century it appears that proper commercial exploitation became commonplace. Commercial coal mining had been a feature of the Halbeath area since at least the 1840s (www.scottishmining.co.uk). Cuttlehill colliery (2) is directly referred to in the New Statistical Account (1845, p 835) in which it is noted that little coal was being produced from that location at that time (1844). The New Statistical Account also makes reference to the exploitation of sandstone, which was described as being of good quality and much used for building purposes (1845; p841).

Assessment of the Archaeological Potential of the Proposed Development Area

11.6.14 The proposed development area has been completely sterilised by 20th century opencast coal mining works; the extent of the former mine working is shown on Figure 11-1. The former mine workings have subsequently been reinstated, landscaped and restored to agricultural use. Those few historic farmsteads and 19th century deep mines that were formerly present have all been removed by the later opencast working and subsequent reinstatement. The proposed development area, therefore, has no archaeological potential.

11.7 IMPACT ASSESSMENT

11.7.1 The results of the baseline study were provided as GIS data with the locations of the former cultural heritage sites identified along with the extent of the former opencast mine working. There are no cultural heritage constraints to the siting of turbines or other infrastructure elements within the proposed development boundary and, therefore, the layout is not constrained by the necessity of avoiding direct impacts.

CHAPTER 11 CULTURAL HERITAGE

- 11.7.2 The assessment of impacts is based upon the proposed devleopment layout shown on Figure 11-1 and is structured as follows:
 - Direct (Construction) Impacts.
 - Indirect (Operational) Impacts.
 - Cumulative Impacts.

Direct (Construction) Impacts

11.7.3 There are no cultural heritage constraints in respect of archaeology and, as a result, there would be no direct impact on any sites or features of archaeological or historic environment interest.

Indirect (Operational) Impacts

- 11.7.4 A list of those external receptors within 10 km of the proposed development and predicted by the ZTV to have theoretical views to one or more turbines is provided in Appendices 11.2 and 11.3 with their locations shown on Figure 11-2.
- 11.7.5 The proposed development would be located on flat reclaimed arable farmland immediately south of the Hill of Beath. The proposed development area is bounded by the M90 motorway on its western side and by the A92 carriageway on its south side. The blade tip ZTV of the proposed development (Figure 11-2) indicates that the proposed turbines would be mostly visible within a wide arc from Glenrothes, in the northeast, to Alloa, in the west. The natural topography of hills would limit the views of the proposed development to the north.
- 11.7.6 Appendix 11.2 provides a summary assessment of the predicted indirect impacts on a siteby-site basis of the key cultural heritage receptors within 5 km of the nearest proposed turbine over which it is considered the proposed development will have the most visual influence. These sites are discussed further in paragraphs 11.7.10 to 11.7.28. The assessment of the magnitude of impacts provided in Appendix 11.2 has been based on analysis of the blade tip ZTV, taking into account the:
 - distance of the assessed site from the proposed development;
 - number of blade tips visible; and
 - current baseline setting of each site.
- 11.7.7 The ZTV model is, however, a coarse predictive tool based on bare-earth surface topography and maximum blade-tip heights. It takes no account of obstructions to intervisibility caused by existing forestry and other vegetation or buildings and other manmade features. Therefore, professional judgement has been used to assess the significance of impacts informed by the ZTV and field survey. Where Historic Scotland has requested visualisations these have been used to further assess predicted impacts on setting (Table 11.10, Figures 11-3 to 11-5).
- 11.7.8 Appendix 11.3 provides a list of the key cultural heritage receptors within 5-10 km of the nearest proposed turbine. The majority of these monuments lie in built-up areas and the setting of these is the urban environment that constitutes their baseline settings. Taking into consideration the scale of the proposed development (in total four turbines) and the surrounding landscape character, which is predominantly urban, it is judged that these cultural heritage sites would receive no adverse impact from the proposed development. Unless their settings have been requested by Historic Scotland or the Fife Council Archaeologist to be assessed in the ES they are not considered further.

CHAPTER 11 CULTURAL HERITAGE

11.7.9 No significant impacts have been predicted on the setting of cultural heritage receptors in the wider landscape. Sites within 5 km of the proposed development are discussed in detail below.

Scheduled Monuments

- 11.7.10 Three cropmark sites: Lumphinnans Henge (6253); Middlebank House Souterrain (8854); and Balbougie Enclosed Settlement (8555) are present within 5 km of the proposed development. These sites all lie within areas of arable farmland. No upstanding remains survive of these sites and their settings add little to their value or significance as an archaeological resource. All sites lie over 4 km from the proposed development and would retain their immediate farmland setting. It is, therefore, considered that the proposed development would have an imperceptible magnitude impact of negligible significance on their settings.
- 11.7.11 All other Scheduled Monuments within 5 km of the proposed development predicted to have visibility of the proposed turbines stand within the town of Dunfermline. These include Easter Pitcorthie Standing stones; Perdieus Mount Motte (867); North Wood, cairn (8556); Heugh Mills (9285) and Dunfermline Abbey (90116) and associated structures (9276, 90339). The current setting of these Scheduled Monuments is the built-up environment of the town and the relationship of each to the surrounding buildings and other town structures. The proposed development would not affect their current settings, the impacts on the individual monuments being of imperceptible magnitude and of negligible significance.

Listed Buildings

Blair Adam (5715)

11.7.12 This Category A Listed building, which Historic Scotland specifically requested be assessed, is situated just over 6 km to the north of the proposed development. It forms part of the Blair Adam GDL (discussed below). The house was built in the mid-18th century for the Blair-Adam family, but was sold in the 1920s when the estate was broken up and was used as a hotel for a number of years until it was eventually repurchased by the Blair-Adam Family and restored in the 1970s. The 2-storey five-bay mansion house stands on the eastern edge of the Blair Adam Forest and is surrounded by parkland. The five-bays of the house form an enclosed inner courtyard from which there are limited views out to the surrounding landscape and views out onto this courtyard will not be affected by the proposed development. Views are gained from the outer elevations of the house itself to the north, east and south; views to the west being limited by woodland. Wide open views are particularly afforded from the south side of the house overlooking the estate parkland and flat arable fields, with the town of Kelty visible in the background. A wireframe

produced from the car park area on the southern side of the house (Figure 11-3) indicates that a natural rise in topography will limit views to the proposed development from this location with only one hub and one turbine tip being theoretically visible. The proposed development would not be a prominent feature in the wider landscape and its presence would not detract from an appreciation of the listed building or its immediate setting. Taking this into consideration it is judged that the proposed development would have an imperceptible magnitude impact of negligible significance on the setting of the house.

Fordell Castle (3652)

- 11.7.13 The Category A Listed Castle was built in the mid-16th century, replacing an earlier building. The building stands on a promontory overlooking the Fordell Burn, which encloses the castle and its surrounding gardens on three sides. The castle and its associated gardens stand within a slight hollow surrounded by dense woodland which screens both views out from the castle and views of the castle from the surrounding landscape and provides a secluded and sheltered location for the castle and its garden. The castle was left unoccupied in the 19th century when the Henderson family moved from the castle to the newly constructed Fordell Mansion (subsequently demolished in 1960s). The castle was bought by Sir Nicholas Fairburn in the 1960s and restored along with its surrounding Italianate gardens. It forms part of the Fordell Castle GDL (paragraph 11.7.20).
- 11.7.14 The castle lies just over 4 km to the south of the proposed development. The blade tip ZTV for the proposed development (Figure 11-2) and a wireframe (Figure 11-4) produced from a viewpoint within the raised terraces of Fordell Castle, which lie immediately north of the Castle, indicate that there would be no visibility of the proposed turbines from Fordell Castle itself or its surrounding garden. Therefore the proposed development would have no impact on the setting of the castle.

Fordell Chapel (3653)

- 11.7.15 The Category A Listed chapel was constructed in the mid-17th century for the Hendersons of Fordell and is dedicated to St. Therotus. The chapel stands in a secluded spot on the edge of the formalised gardens that surround Fordell Castle, approximately 200 m southwest of the castle. The chapel was left unused in the 19th century when the Henderson Family moved from the castle to the newly built Fordell Mansion (subsequently demolished in the 1960s). The chapel was then subsequently restored in the late 1990's following restoration of the castle and its surrounding formalised gardens.
- 11.7.16 The chapel is situated approximately 4.2 km to the south of the proposed development, standing at the southwestern edge of the formalised gardens and surrounded on three sides by forestry (on the east, south and the west sides); the north side of the chapel looks out onto the castle's formalised gardens. The chapel is accessed by a number of paths leading through the gardens from the castle. The blade tip ZTV (Figure 11-2) indicates that visibility from the chapel would be limited to views from the western end of the chapel. This does not, however, take into consideration the screening provided by the extensive woodland that surrounds the castle, its gardens and the chapel, which would screen any views to the proposed turbines. The proposed turbines would not affect the immediate setting of the chapel nor affect its relationship with Fordell Castle or the formalised gardens in which it stands and of which it forms a part. It is therefore judged that the proposed development would have an imperceptible magnitude impact of negligible significance on the setting of the chapel.

Other Listed Buildings

- 11.7.17 The majority of listed buildings within 5 km of the proposed development lie within the town of Dunfermline and form part of the Dunfermline Town Centre Conservation Area. The setting of these buildings is the built environment of the town and their relationship to the group of related buildings and other town features that surround them. Many are residential properties or shops which do not have extensive views out to the surrounding landscape. It is judged that the impacts on the settings of these buildings would be of imperceptible magnitude and of negligible significance.
- 11.7.18 Several other listed historic country houses and farm buildings are also present within 5 km of the proposed development. These buildings are generally located in small designed landscapes or enclosed farmsteadings. The setting of these various historic buildings is the group of related farm buildings or the designed landscape of which they are an integral part. The presence of the proposed development would not materially affect those relationships and the character of the landscape in which they lie would remain unaffected. It is considered that the impacts on the settings of these buildings would be no more than of imperceptible magnitude and of negligible significance.

Inventory Gardens and Designed Landscapes

11.7.19 There are two designed landscapes (GDLs), Fordell and Pittencrieff Park, within 5 km of the proposed development, that are predicted by the blade tip ZTV to have visibility of the proposed turbines. Historic Scotland also requested that a further designed landscape, Blair Adams, which lies over 6 km from the proposed development be assessed as part of the ES.

Fordell GDL

- 11.7.20 The designed landscape at Fordell is situated between the M90 motorway, in the west, and the Cullaloe Hills, in the east. The GDL lies approximately 4.2 km to the south of the proposed development and principally comprises mixed woodland that surrounds Fordell Castle (discussed above) and small areas of open parkland at the edges of the GDL. Formalised gardens are set out around the castle which stands in a secluded area of the GDL surrounded by woodland. Other listed buildings also form part of the designed landscape including Category A Listed Fordell Chapel (3653) (discussed above), Category B Listed Fordell Nursery (49162), Vantage Farm Dovecot (3663) and Pitardo House (49164), and Category C(S) Listed Vantage Farm (3662) and North West Gate (49163).
- 11.7.21 The ZTV indicates that there would be no visibility of the proposed turbines from the castle itself and that visibility from the southern half of the designed landscape would be limited by a rise in topography. Glimpses of the designed landscape, including its woodland policies and southern parkland (but not the castle) can be gained from the south along the public A921 road and a wireframe produced for a viewpoint along this road orientated on Fordell Castle (Figure 11-5) indicates that four turbine hubs would be theoretically visible in a small arc of view beyond the skyline. The wireframe does not however take into account screening of the proposed turbines from the intervening woodland of the GDL itself.
- 11.7.22 Formalised gardens surround Fordell Castle, which include raised terraces immediately north of the castle. A wireframe (Figure 11-4) produced from this location indicates that none of the proposed turbines would be visible. The other listed buildings which form part of the GDL either lie in enclosed farm settings or are surrounded by woodland. None were

intended to have long distant views out to the surrounding landscape and the presence of the proposed development would not affect their immediate setting.

11.7.23 It is considered that the proposed development would not affect the setting of the designed landscape as a whole, would not affect any designed views or vistas nor would it affect the relationship of the buildings and features sited within it. It is judged overall that the impact on the GDL would be of imperceptible magnitude and of negligible significance.

Pittencrieff Park GDL

- 11.7.24 Pittencrieff Park is situated on the west side of the town of Dunfermline just under 5 km from the proposed development area. The park which once formed the designed landscape that surrounded Pittencrieff House was gifted to the people of Dunfermline in 1903 by Andrew Carnegie and is now a public park. The park slopes to the south and the main views out from both the park and Pittencrieff House, which lies at the centre of the park, focus southwards to the Forth Road Bridge and the Lothian Hills. Views into the park from the surrounding landscape are limited by the high walls of the park.
- 11.7.25 The presence of the proposed turbines, to the northeast of the park and situated beyond the built environment of the town of Dunfermline, would not detract from an appreciation of the park or the buildings/structures within in it, nor will the development be visible in principal views southwards from the park. It is, therefore, considered that the proposed development would have an impact of imperceptible magnitude and of negligible significance on the setting of the park.

Blair Adam GDL

- 11.7.26 This designed landscape, which Historic Scotland specifically requested be assessed, is situated just over 6 km to the north of the proposed development, on the eastern slopes of the Cleish Hills. The designed landscape comprises mixed deciduous woodland and open parkland that surrounds Category A Listed Blair Adam House (5715) (discussed above) and includes other associated listed buildings, including: Category B Listed Coach House (5716) and North Blair, small policy house (5717), walled gardens and the Blair Adam commemorative monument standing in the walled garden. The blade tip ZTV (Figure 11-2) indicates that views of the turbines would be restricted, by topography, to limited locations at the northern edge and central part of the designed landscape; the listed walled garden and commemorative monument being unaffected. Wide views can be gained from the designed landscape to the north taking in the Firth of Tay and the Sidlaw Hills, south to the Pentland Hills, and east to the Firth of Forth.
- 11.7.27 Limited views of the proposed turbines would be visible in views to the south from the designed landscape and from Blair Adam House (5716) (Figure 11-2). A wireframe produced for the house (Figure 11-3) indicates that one hub and one turbine tip would theoretically be visible in the far distance beyond the skyline and the M90 motorway. Although the proposed turbines would be a new industrial element in the wider landscape it is considered that their presence would not affect the setting of the GDL as a whole, would not affect the relationship between the buildings or other designed features / structures that are sited within the GDL, or affect any specific vistas or views within the GDL. The impact of the proposed development of the setting of the GDL is judged to be of no more than imperceptible magnitude and of negligible significance.

Conservation Areas

11.7.28 One Conservation Area, Dunfermline Town Centre, lies within 5 km of the proposed development. The Conservation Area covers the historic core of the town including approximately 80 listed buildings, such as the Category A Listed Dunfermline Abbey, Logie House and Abbot House. The town is a former capital of Scotland, having been historically a seat of the Kingdom's Royal Court and an important ecclesiastical centre. Later industrial areas and further urban buildings have enclosed the historic core of the town and the Conservation Area sits in a built urban environment. The proposed turbines, which would be located approximately 4.4 km to the northeast of the Conservation Area, would be visible beyond the built environment although would not be dominant industrial elements in the surrounding landscape. Their presence would not affect the setting of the Conservation Area as a whole nor would they affect the relationship of the buildings and other structures within the Conservation Area is of imperceptible magnitude and negligible significance.

11.8 MITIGATION

- 11.8.1 There would be no direct impacts on any sites or features of cultural heritage interest arising from the construction of the proposed development and therefore no mitigation is required within the proposed development area.
- 11.8.2 Impacts arising from the operation of the proposed development are identified as negligible for all heritage assets and therefore no mitigation is proposed.

11.9 RESIDUAL IMPACTS

- 11.9.1 The proposed development area has been almost completely sterilised by 20th century opencast coal mining and there would be no direct impacts on any sites and features of cultural heritage arising from the construction of the proposed development. Taking this into account there would be no residual direct impacts in relation to cultural heritage assets.
- 11.9.2 There will be no significant impacts on the setting of any key cultural heritage assets within the wider landscape; therefore, the proposed development will not have a significant residual impact on the setting of any of these sites.

11.10 CUMULATIVE IMPACT ASSESSMENT

- 11.10.1 Within 10 km of the proposed development there are two approved wind development schemes: Little Raith (nine turbines) and Pitreavie Business Park (one turbine); and three wind developments in planning: Mossmorran (two turbines), Lochend Farm (one turbine) and Lynnside (one turbine). Between 10 km and 20 km from the proposed development there are three other schemes at the application stage: Westfield (five turbines), Strathore farm (one turbine) and Earlseat (nine turbines). Beyond 20 km there are four installed wind farms (Greenknowes (18 turbines), Lochelbank (12 turbines), Methil Docks (1 turbine) and Burnfoot Hill (13 turbines) and a further six at the application stage.
- 11.10.2 In terms of the potential cumulative impact on the settings of cultural heritage assets within 15 km of, and which have predicted views of, the proposed development, the greatest cumulative effect is likely to arise from the development in combination with the approved Little Raith wind farm (nine turbines), which would be located approximately 6 km to the east northeast.

CHAPTER 11 CULTURAL HERITAGE

- 11.10.3 Historic Scotland identified Blair Adam GDL (including Blair Adam House) and Fordell Castle GDL (including Castle and Chapel) as key sensitive receptors whose settings could be affected by the proposed development and it is these, therefore, that are particularly relevant to the cumulative impact assessment. The other cultural heritage assets in the wider landscape vary in character, although there is a predominance of listed buildings, the majority of which are located in urban environments or in small enclosed designed gardens / farmsteads. These principally have localised settings and long views out to or from the surrounding wider landscape are incidental and not especially relevant to their heritage value. In most cases it is considered that the cumulative impact on these individual listed buildings would not be significant.
- 11.10.4 In the case of both Blair Adam and Fordell castle GDLs the two wind farms (Kingdom of Fife scheme and Little Raith) would not be seen in the same view from anywhere within the designed landscape. The cumulative ZTV (Figure 7-39) shows that both developments would be potentially visible to some degree from within the grounds but each would lie in different directions. From Blair Adam, both schemes would be approximately equidistant (approximately 6 km away) and from Fordell the Kingdom of Fife scheme would be 4.2 km distant and Little Raith approximately 6.5 km away.
- 11.10.5 The assessment of impact on the settings of the two GDLs identifies a negligible significance effect for each and it is assessed that the cumulative impact arising from the proposed development in combination with the Little Raith scheme would be of no more than low magnitude and minor significance. The other proposed schemes that lie within 10 km of the proposed development (Mossmorran, Lochend Farm and Lynnside) are each small proposals; Lochend Farm and Lynnside being single turbines under 80 m to tip height. Mossmorran is a proposal for two turbines 100 m to tip and would lie between Fordell Castle GDL and Little Raith; there would be no significant cumulative impact on the settings of either GDL from the proposed development in combination with any of these other schemes.
- 11.10.6 Other wind developments all lie more than 10 km from the proposed development; those are now installed all being more than 20 km distant. These schemes would only be seen in the far distance, if at all, from receptors whose settings would be affected to some degree by the proposed development and this fact would not result in any significant cumulative impact.

11.11 CONCLUSION

- 11.11.1 The proposed development area has been almost completely sterilised by 20th century opencast coal mining works. The former mine workings have subsequently been reinstated, landscaped and restored to agricultural use. The few historic farmsteads and 19th century deep mines that were formerly present have all been removed by the later opencast workings and, therefore, the site has no archaeological potential.
- 11.11.2 There would be no direct impacts on any sites or features of cultural heritage interest arising from the construction of the proposed development.
- 11.11.3 29 Scheduled Monuments, 19 Category A Listed Buildings, 109 Category B Listed Buildings, 55 C(S) Listed Buildings; six Inventory Gardens and Designed Landscapes, and three Conservation Areas were identified within 10 km of the proposed development. No significant impacts on the setting of these features are predicted.
- 11.11.4 The cumulative impact of the proposed development in combination with other developments in the vicinity is considered not to be significant.
