### 1. INTRODUCTION

#### 1.1 General

- 1.1.1 This report presents the results of an archaeological watching brief undertaken by CFA Archaeology Ltd (CFA) at the Orocco Pier Hotel, 17 High Street, South Queensferry (NGR: NT 1298 7837) (Fig. 1). The work was commissioned by KB Architecture + Design Ltd (KBA+D) on behalf of Renaissance Ecosse.
- 1.1.2 A Written Scheme of Investigation (WSI) (dated 18<sup>th</sup> November 2008) for the project was produced by CFA on behalf of KBA+D. The WSI was designed to meet the requirements of the City of Edinburgh Council Archaeology Service (CECAS).

### 1.2 Background

- 1.2.1 The NMRS mentions that the hotel stands on the site of the former Glenforth Distillery (NMRS No. NT17 NW 82) (established 1828). However, this is incorrect; the hotel (formerly the Queensferry Arms Hotel) adjoined the distillery and is an earlier Category B-Listed building (HB No. 40376).
- 1.2.2 Previously planning permission was granted by the City of Edinburgh Council (Ref No. 06/03332/FUL) for the alteration and extension of the Orocco Pier Hotel, subject to a condition requiring a programme of archaeological works. The agreed programme of archaeological works consisted of a desk-based assessment, a standing building survey and an evaluation. The results of evaluation are contained in CFA Data Structure Report No. 1376 (Suddaby 2007), and the results of the desk-based assessment and standing building survey are contained in CFA Data Structure report No. 1379 (Cressey 2007). Based on the results of the evaluation the requirement for a watching brief was attached to the downtaking of walls and excavation of foundations associated with a new extension to the rear of the hotel. To date this part of the development has not been built.
- 1.2.3 The current application (08/03527/FUL) for an extension of the hotel into adjacent properties was granted with a condition for an archaeological watching brief on all groundbreaking works and on internal and external structural alterations, a WSI for this was provided to CECAS and agreed in advance of works starting. However, a watching brief was only carried out on groundbreaking for the construction of a retaining structure within the lower ground floor (Fig. 1). Photographs of the structural alterations were taken by the main contractor and a selection of these will be submitted to CECAS under separate cover by KBA+D.

### 2. ARCHAEOLOGICAL RESULTS

### 2.1 General

2.1.1 CFA Archaeology Ltd follows the Institute for Archaeologists' Code of Conduct, Standards and Guidance for Archaeological Fieldwork.

### 2.2 Watching Brief

- 2.2.1 A watching brief was conducted on the lower ground floor of the extension where a retaining structure was constructed along the front of the building (Fig. 1).
- 2.2.2 The building appeared to have been terraced in to the natural slope with the front wall foundations being cut in to sand. In order to construct the retaining structure a bank of compacted sand had to be removed from behind the front wall, this bank of sand was presumably left *in situ* at the time of the original construction to retain the wall. A foundation trench then had to be excavated along the front wall.
- 2.2.3 Over 1m of laminated windblown sands containing occasional thin soil horizons was removed from up against the wall to get the working area down to the current floor level of the lower ground floor. The foundation for the new retaining wall was then excavated to c. 1m below that. All the deposits identified consisted of laminated sand containing occasional thin soil horizons (Fig. 3 & 4). There were no features, artefacts or deposits of archaeological significance identified.

### 3. CONCLUSION

- 3.1 A watching brief was carried out during the construction of a retaining wall along the front of the extension to the Orocco Pier Hotel. The watching brief established that the foundations of the hotel had been cut into laminated windblown sands containing occasional thin soil horizons. Whilst such deposits can mask archaeological layers none were present within the area that was monitored.
- 3.2 The project archive, comprising all CFA record sheets, maps and reports, will be deposited with the National Monuments Record of Scotland (NMRS) and copies of reports will be lodged with CECAS.
- 3.3 A summary statement to be submitted for publication in *Discovery and Excavation in Scotland* (Appendix 1) will be sufficient to disseminate the results of this watching brief. An OASIS project record form will also be submitted.












Fig. 2 - Area after removal of bank of sand




Fig. 3 - Foundation trench of retaining structure
