1 Summary

An archaeological evaluation by trial-trenching was carried out in advance of the construction of eight new dwellings at Kirkmead, Clacton Road, Weeley. Dispersed settlement is recorded along Clacton Road with 17th- and 19th-century listed buildings and a possible deserted medieval village with a church/hall complex at Weeley Hall. Three of the trial-trenches revealed no significant archaeology. The remaining two trenches contained ditches, pits, postholes and natural features. Most were undated but are probably post-medieval/modern and agricultural in origin.




Fig 1 Site location.

2 Introduction (Fig 1)

This is the archive report for an archaeological investigation by trial-trenching at Kirkmead, Clacton Road, Weeley, Essex which was carried out on 22nd March 2016. The work was commissioned by Colin Crawley of Chelsteen Homes in advance of the construction of eight new dwellings. The work was undertaken by Colchester Archaeological Trust (CAT).

In response to consultation with Essex County Council Place Services (ECCPS), Historic Environment Advisor Adrian Gascoyne advised that, in order to establish the archaeological implications of this application, the applicant should be required to commission a scheme of archaeological investigation in accordance with the *National Planning Policy Framework* (DCLG 2012).

All archaeological work was carried out in accordance with a *Brief for Archaeological Trial Trenching*, detailing the required archaeological work, written by Adrian Gascoyne (ECCPS 2015), and a Written Scheme of Investigation (WSI) prepared by CAT in response to the brief and agreed with ECCPS (CAT 2015).

In addition to the brief and WSI, all fieldwork and reporting was done in accordance with English Heritage's *Management of Research Projects in the Historic Environment* (*MoRPHE*) (English Heritage 2006), and with *Standards for field archaeology in the East of England* (EAA 14 and 24). This report mirrors standards and practices contained in the Institute for Archaeologists' *Standard and guidance for archaeological field evaluation* (CIfA 2014a) and *Standard and guidance for the collection, documentation, conservation and research of archaeological materials* (CIfA 2014b).

3 Archaeological background

The following archaeological background utilises the Essex Historic Environment Record (EHER) held at Essex County Council, County Hall, Chelmsford.

The Tendring Historic Environment Characterisation project identified that the area of the proposed development has good potential for below ground archaeological remains. This includes a possible deserted medieval village with church/hall complex identified at Weeley Hall (EHER 3028). Two listed buildings of 17th- and 19th-century date are located to the south of the site showing dispersed settlement along the Clacton Road.

Gravels on the northern side of the river have also produced Pleistocene and Palaeolithic remains within surface geology (EHER 3086).




Fig 2 Evaluation results.

4 **Results** (Figs 2-4)

Five trial-trenches were excavated across the development site. Three layers were identified. Modern topsoil (L1, c 200-300mm thick) sealed a thin layer of subsoil (L2, c 80-100mm thick), which sealed natural silty-clay (L3).

Trench 1 (T1), 30m long by 1.8m wide

No archaeological features or finds were identified.


Two natural features were identified (F9 and F13) along with a shallow ditch (F12), pit (F10) and posthole (F11). All of the features are undated but are thought to be fairly modern and agricultural in nature.

Trench 5 (T5), 30m long by 1.8m wide

Two natural features were identified (F3 and F8) along with a pit (F2), six postholes (F1, F4, F5, F6, F7, F16) and two ditches (F14 cut by F15). The features are largely

undated (see Section 6) but thought to be post-medieval/modern and agricultural in nature.

5 Finds

No archaeological finds were recorded from T1-T4.

The two small fragments of Roman greyware pottery are very abraded and are likely to have been churned around in the ploughsoil for a considerable period of time. They are both likely to be much older than the features they were recorded in.

6 Discussion

No significant archaeological horizons were identified in three of the trial-trenches (T1-T3) located in the northwest half of the development site. The remaining two trenches (T4-T5) contained three ditches, two pits, seven postholes and four natural features. The ditches, pits and postholes were largely undated but are probably postmedieval/modern and agricultural in origin.




Fig 3 T4-5: Detailed trench plans.




Fig 4 Feature sections (F1-2, F4, F8, F10 and F14-F16) and representative trench sections (T2, T5).
