### 1 Summary

An archaeological evaluation (two trial-trenches) was carried out at Phase 2, plots 6&7, Blue Barn Farm, Elmstead Market, Essex in advance of the construction of two new detached dwellings with associated garages and access. The development site is located within an area of cropmarks, including that of a possible trackway leading from Elmstead Market. The evaluation revealed two pits, one modern and one undated and two modern services. There was no evidence of features relating to the projected cropmarks or any finds.




Fig 1 Site location showing trenches T5 and T6 in relation to the April 2017 evaluation trenches T1-T4, the proposed development (dashed blue) and the cropmarks (green)

### 2 Introduction (Fig 1)

This is the archive report for an archaeological evaluation by trial-trenching at Blue Barn Farm, Elmstead Market, Essex. Fieldwork was carried out on 11th December 2017. The work was commissioned by Stephen Williams, of Hills Residential. Work was in advance of the construction of two new detached dwellings with associated garages and access, and was undertaken by Colchester Archaeological Trust (CAT).

In response to consultation with Essex County Council Place Services (ECCPS), Historic Environment Advisor Teresa O'Connor advised that in order to establish the archaeological implications of this application, the applicant should be required to commission a scheme of archaeological investigation in accordance with the *National Planning Policy Framework* (DCLG 2012).

All archaeological work was carried out in accordance with a written scheme of investigation (WSI) prepared by CAT and agreed with ECCPS (CAT 2017). After discussion with ECC Place Services, it was decided that a Brief would not be issued and that the Specialist Archaeological Advice issued to Tendring District Council Planning Services would be sufficient for the preparation of the Written Scheme of Investigation.

In addition to the brief and WSI, all fieldwork and reporting was done in accordance with English Heritage's *Management of Research Projects in the Historic Environment* (*MoRPHE*) (English Heritage 2006), and with *Standards for field archaeology in the East of England* (EAA **14** and **24**). This report mirrors standards and practices contained in the Institute for Archaeologists' *Standard and guidance for archaeological field evaluation* (CIfA 2014a) and *Standard and guidance for the collection, documentation, conservation and research of archaeological materials* (CIfA 2014b).

## 3 Archaeological background

The following archaeological background utilises the Essex Historic Environment Record (EHER) held at Essex County Council, County Hall, Chelmsford.

The EHER shows that the development site lies within an area which has substantial archaeological evidence, as recorded by aerial photography and seen in cropmark features. The cropmark plot (provided by the EHER) provides evidence for a possible trackway crossing the site indicated by two parallel linear features running NW-SE, they extend across the landscape for over 800m and lead from the village at Elmstead Market which is historic in origin. The road through the village is thought to be Roman in origin and this track may be associated with this or could be later, possibly medieval, in date. In addition, there are two further parallel linear features close by, aligned NW-SE (to the south of the main trackway) and NE-SW (Fig 1) all indicating historic settlement activity. Both Roman and medieval finds have been recovered from the area through metal detecting, including pottery and glass vessels, coins and jewellery.

Former farm buildings associated with the site of Blue Barn Farm are depicted on the 1st edition OS maps and so must pre-date c 1870 and are likely to be earlier in origin. These buildings are no longer extant but lie within the area of development. Below

ground remains for the buildings may survive which could provide an indication of age and origin for the site. A pond was located beside the farm buildings which may preserve waterlogged deposits or stratified archaeological deposits.

In April 2017 CAT undertook an archaeological evaluation (four trial-trenches) in advance of the construction of five new dwellings with associated garages and access to the southeast of the current site (CAT Report 1094). The evaluation revealed two medieval ditches, three undated (but probably medieval) ditches, three undated small pits/postholes, two modern features (a pit and ditch) and two tree-throws containing residual medieval pottery. The ditches appear to be field boundaries within a medieval, *c* 12th/13th-14th century, field-system. One of the ditches (F2) was on a similar alignment as the trackway cropmark, but given the distances involved between the edge of the cropmark and the feature (250m) it is impossible to determine if they are related.

#### 4 Aims

Plot 6 was located to straddle the projected trackway (WSI Fig 1), targeted by a 15m long by 1.8m wide trench (T6), in an attempt to locate the trackway ditches. This was to be extended if necessary to confirm the full profile of each ditch identified. The footprint of Plot 7 was to be evaluated by a 10m long by 1.8m wide trench (T5). The proposed driveways for each of these plots will have minimal formation depths (150mm as confirmed by the developer). Consequently it has been decided not to evaluate these areas.

As the development area is 0.14ha the total minimum trenching  $(45m^2)$  will be just over 3%.

Specific research aims were to identify:

- A continuation of the main trackway and other cropmarks through the site.
- Potential roadside settlement or activity along Clacton Road.

#### 5 Methodology

Two archaeological trial-trenches were machine excavated under the supervision of a CAT archaeologist. Both trenches were positioned to target potential cropmarks or features on the 1st edition OS map (see above). Trench, feature and layer numbers continue on from the previous evaluation on adjacent plots (CAT Report 1094).




Fig 2 Results (modern features in grey)

#### 6 Results (Figs 2-3)

#### Trench 5 (T5): 8m long by 2m wide

Due to an overhead power cable Trench 5 had to be shortened in length by 2m. It was excavated through modern topsoil (L2, 0.3-0.42m thick) onto mid orange and brown natural sands and gravels (L4) to a trench depth of 0.48-0.55m.

The north-eastern third of T5 was not excavated due to the presence of a modern water main. At the southwestern end was an undated pit F15 (0.7m wide, 1.31m long by 0.32m deep) with a fill was loose mid brown silt.

#### Trench 6 (T6): 15m long by 2m wide

Trench 2 was excavated through modern topsoil (L2, 0.32-0.35m thick) onto natural sands and gravels (L4) to a trench depth of 0.50-0.54m. An additional 0.2m slot was excavated below the general depth of the trench to confirm no further layers were present.

Towards the northeastern end of T6 was a small shallow modern feature F14 (0.64m long, 0.52m wide by 0.11m comprised of firm mid brown silt deep which contained fragments of modern frogged bricks (none retained).

## 7 Finds

There were no archaeological finds.

## 8 Discussion

Archaeological evaluation of plots 6 & 7, Blue Barn Farm, Elmstead Market revealed one modern pit, one undated pit and two modern services. There was no sign of ditches thought to perhaps link to cropmarks to the northeast of the site, or with medieval ditch F2 in T3, thought to be part of a medieval agricultural landscape. The level of the natural is quite high at 25.02m AOD in T5 and 25.70m AOD in T6, similar to those seen in T1 (25.05m AOD) and T2 (25.61m AOD). Apart from the modern disturbance in T5 and a modern service crossing T6 both trenches were completely devoid of any finds, even residual in the topsoil.




Fig 3 Feature and representative sections.
