Non Technical Summary

This report results from work undertaken by Cambrian Archaeological Projects Ltd (CAP) for Engena Ltd of Bury St. Edmunds, Suffolk. The work carried out consisted of a desk based assessment and a field walkover survey in advance of proposed construction of 12 wind turbines at Cottam in Nottinghamshire. The desk-based assessment appraised the documentary, photographic and cartographic evidence pertaining to the site and its immediate environs whilst the field walkover assessed the area for any visible archaeological remains.

1 Introduction

1.1 Location and scope of work

- 1.1.1 In October/November 2007 Cambrian Archaeological Projects (CAP) carried out a desk based assessment and field walkover survey of land to the north of Cottam, Nottinghamshire (Fig 1), on behalf of their clients Engena Ltd.
- 1.1.2 This work was carried out in respect of a proposed wind farm development on the site. The development concerns the construction of 12 wind turbines on the site with associated access tracks centred on NGR SK 805140 808350 (See Fig 2).
- 1.1.3 A method statement for the desk based assessment and field walkover survey was prepared by Kevin Blockley MIFA FSA and forwarded to the Nottinghamshire development control officer.

1.2 Geology and topography

- 1.2.1 The Topography of the area of proposed development is largely flat and un-wooded although some small areas of woodland exist to the south west. The landscape is characterised by post World War 2 modified field systems and small nucleated village settlements.
- 1.2.2 The underlying solid geology of the Cottam area is mainly composed of Triassic mudstones including Keuper Marl, Dolomitic Conglomerate and Rhaetic (BGS, 1979).

1.3 Archaeological and historical background

- 1.3.1 This section provides a brief description of the archaeological and historical background to the area of proposed development.
- 1.3.2 The area of proposed development lies within a larger archaeological landscape dating back to the Neolithic, Bronze and Iron Ages as evidenced by crop marks and stray finds. The main period of activity however is the Romano-British period. The Roman town of *Segelocum* (Littleborough), adjacent to the Roman road running north west south east, would have formed a focal point within the landscape. Around the town and road ancillary activities such as agriculture would have taken place evidence for which may be seen in possible late Iron Age/ Romano-British field system crop marks in the area. Burials are also likely to have taken place adjacent to the Roman road outside the town limits at this time.

1.3.3 Evidence of medieval and post medieval activity within the area of proposed development is the most common with both cropmarks and earthworks showing evidence of agriculture. Historic settlement cores are present in the villages of the area such as Cottam, South Leverton, North Leverton with Habblesthorpe as well as the Roman town of Littleborough (Segelocum).

2 Aims and Objectives

- 2.1 The main scope and objectives of the archaeological assessment were to reveal by desk-based study, the nature, significance and, where possible, the chronology of the archaeology within the area of the proposed development. The purpose of the desk-based assessment, in accordance with standards and guidance as laid down by the *Institute of Field Archaeologists*, is to gain information about the known or potential archaeological resource within the given area (including presence or absence, character and extent, date, integrity, state of preservation and relative quality of the potential archaeological resource), in order to make an assessment of its merit in context, leading to one or more of the following:
 - The formulation of a strategy to ensure the recording, preservation or management of the resource;
 - The formulation of a strategy for further investigation, whether or not intrusive, where the character and value of the resource is not sufficiently defined to permit a mitigation strategy or other response to be devised;
 - The formulation of a proposal for further archaeological investigation within a programme of research.
- 2.2 With regards the field survey the main objective in accordance with the standards and guidance laid down by the *Institute of Field Archaeologists* is to gain information about the archaeological resource within a given area or site (including presence or absence, character, extent, date, integrity, state of preservation and quality), in order to make an assessment of its merit in the appropriate context, leading to one or more of the following:
 - The formulation of a strategy to ensure the recording, preservation or management of the resource:
 - The formulation of a strategy to mitigate a threat to the archaeological resource;
 - The formulation of a proposal for further archaeological investigation within a programme of research.
- 2.3 The field study aimed to examine on the ground the land designated for the proposed wind farm and isolate and record any archaeology and historic landscape features that survive within it.

3 Methodology

3.1 For the purposes of the archaeological desk based study the following repositories were consulted:

- Regional Sites and Monuments Record
- Portable Antiquities Scheme (Nottinghamshire)
- Cambridge Air Photo Unit
- Envirocheck/Landmark Mapping
- County Records Office (Nottinghamshire Archives)
- 3.2 At these repositories the following sources were consulted:
 - All Ordnance Survey Maps
 - Tithe Enclosure Award and Parish Maps
 - Estate Maps
 - Historical documents pertaining to the site
 - Archaeological books and journals
 - Unpublished reports
 - Aerial photographs
- 3.3 At the Nottinghamshire Sites and Monuments Record a 3.5km search around the centre of the development area was undertaken. This was then supplemented with a similar search of data held by the Archaeology Data Service.
- 3.4 For purposes of the Field Study once all cartographic and archaeological records had been consulted and all relevant material identified, the proposed development areas were subject to a field walkover. A finds sampling strategy was in place during the field study should any surface scatters of pottery sherds or other potential finds warrant it.
- 3.5 The assessment methods used followed that detailed in the DMRB (Design Manual for Roads and Bridges), Volume 11, Section 3, part 2. All sites identified have been categorised following guidelines set out in the DMRB. The allocation of a set value to a site defines the sites archaeological significance. The value categories are described as follows:
 - Very High World Heritage sites (including nominated sites), Assets of acknowledged international importance, Assets that can contribute significantly to acknowledged international research objectives.
 - *High* Scheduled Ancient Monuments (including proposed sites), undesignated assets of schedulable quality and importance, Assets that can contribute significantly to acknowledged national research objectives.
 - Medium Designated or undesignated assets that contribute to regional research objectives.
 - Low Designated and undesignated assets of local importance, assets compromised by poor preservation and/or poor survival of contextual associations, assets of limited value, but with potential to contribute to local research objectives
 - Negligible Assets with very little or no surviving archaeological interest
 - *Unknown* The importance of the resource has not been ascertained
- 3.6 The significance of the impact on the cultural heritage has been assessed with regard to the category of the individual site or landscape, based on the following criteria:

• *No Change*: No change

• Negligible: Very minor changes to archaeological materials, or setting

• *Minor*: Changes to key archaeological materials, such that the asset is

slightly altered. Slight changes to setting

Moderate: Changes to many key archaeological materials, such that the

resource is clearly modified. Considerable changes to setting

that affect the character of the asset.

• Major: Change to most or all key archaeological materials, such that

the resource is totally altered. Comprehensive changes to

setting

4 The Desk-Based Assessment – Search Data

4.1.1 All sites and buildings, as well as their locations, recorded within the study area are shown on Fig 3 and the impact table.

4.2 Palaeolithic

4.2.1 No recorded Palaeolithic finds or activity could be found for this area.

4.3 Mesolithic

4.3.1 No recorded Mesolithic finds or activity could be found for this area.

4.4 Neolithic

Three known Neolithic sites are located within a 1km radius of the assessment area (centre). All three represent find spots, none of which will be impacted upon by the development proposals. A further three early Neolithic finds were made during the field walkover, these were centred on SK 81199 81075.

4.5 Bronze Age

The two suspected sites are identified by cropmarks, one of which (05038) may be impacted upon owing to its proximity to turbines 9 and 10 and their associated access tracks.

5 Map Regression

- 5.1.1 The 1796 enclosure map for South Leverton and Cottam (Fig 4) shows the middle and lower sections of the development area in close detail. The landscape is characterised by a series of small co-axial 'strip' fields and drainage ditches. None of the twelve turbine locations appear to be located near any structures or other features apart from field boundaries.
- 5.1.2 The 1885-88 First Edition Ordnance Survey map (Fig 5) shows the area of proposed development in close detail. The landscape is characterised by a series of small co-axial 'strip' fields and drainage ditches the same as shown 100 years earlier in Fig 4. None of the twelve turbine locations appear to be located near any structures or other features apart from field boundaries. The access track to Turbine 9 appears to cross four field boundaries of the above mentioned 'strip' fields.
- 5.1.3 The 1900 Second Edition Ordnance Survey map (Fig 6) shows largely the same detail as that seen on the first edition with very few if any changes within the proposed area of development. The large plantation to the south of Turbine 5 appears to have been cleared of trees since the publication of the First Edition map in 1885.
- 5.1.4 The 1921-22 Ordnance Survey map (Fig 7)again shows a largely unchanged landscape in the area of proposed development. The plantation south of Turbine 5 now appears to have been completely removed. Also, an area around the location of Turbine 1 appears to have been enclosed and turned into an Osier bed (any of certain Willow trees, especially *Salix Viminalis*, whose flexible branches or twigs are used for making baskets). No other significant changes were noted.
- 5.1.5 The 1947 Ordnance Survey map (Fig 8) again shows a largely unchanged landscape in the area of proposed development. The Osier bed around Turbine 1 is still in place. Some small changes to boundaries within the assessment area are evident but none with direct relevance to the proposed development. No other significant changes were noted.
- 5.1.6 The 1956 Ordnance Survey map (Fig 9) again shows a largely unchanged landscape in the area of proposed development. Whilst the Turbine 1 Osier bed enclosure still

- remains it appears to be by now clear of willows. No other significant changes were noted.
- 5.1.7 The 1978-80 Ordnance Survey map (Fig 10) shows significant change in the field boundaries of the study area since the publication of the 1956 Ordnance Survey map. Field boundary removal appears to have taken place in the area of most of the turbines leading to a much more open landscape. No other significant changes were noted.
- 5.1.8 The 2007 Ordnance Survey map (Fig 11) shows the landscape of the assessment area as it appears today. More boundaries and 'strip' fields appear to have been removed since the publication of the 1978-80 Ordnance Survey map leaving a landscape of largely open fields and drainage ditches. No other significant changes were noted.

5.2 Aerial Photographs

- 5.2.1 The area is generally well covered by aerial photography and various photographs were consulted during the course of the desk top assessment. Those showing positive results are listed below.
- 5.2.2 Plate 1 BKR 71 12th October 1972. This oblique shot is located at grid reference SK 81100 81300 and shows cropmarks 1.5 miles east south east of North Leverton in the area of Turbine 9 and its associated access track. The field across which the access track is proposed shows a wide variety of linear and curvilinear cropmarks.
- 5.2.3 Plate 2 BKR 73 (reverse angle of BKR 71) 12th October 1972. This oblique shot is located at grid reference SK 81100 81300 and shows cropmarks 1.5 miles east south east of North Leverton in the area of Turbine 9 and its associated access track. The field across which the access track is proposed shows a wide variety of linear and curvilinear cropmarks.
- 5.2.4 Plate 3 RC8-GK 122. 30th May 1984. This vertical shot located at SK 81315 81851 shows the area of Turbines 4 12. Owing to the scale of the photograph no clear cropmarks can be identified apart from a defunct field boundary continuation close to Turbine 8 and possible cropmarks close to Turbine 6.
- 5.2.5 Plate 4 RC8-GK 123. 30th May 1984. This vertical shot located at SK 81339 80745 shows the area of Turbines 3 12 and gives the same information as above.
- 5.2.6 <u>RC8-GK 124. 30th May 1984.</u> This vertical shot located at SK 81409 79799 shows the area of Turbine 3 12 and Cottam Power Station. No new sites are visible.
- 5.2.7 RC8-GK 207. 30^{th} May 1984. This vertical shot located at SK 79981 79598 shows the area of Turbines 1-3 & 6 and shows only a defunct field boundary continuation in the area of Turbine 3.
- 5.2.8 RC8-GK 208. 30th May 1984. This vertical shot located at SK 79988 80607 shows the area of Turbines 1 7 (A1). Features observed previously are again visible although no new sites were noted.
- 5.2.9 RC8-GK 209. 30th May 1984. This vertical shot located at SK 80043 81431 shows the area of Turbines 2 7 (A1) and Turbines 10 12. Features observed previously are again visible although no new sites were noted.
- 5.2.10 Zkn-EV 122. 10th August 1995. This vertical shot located at SK 82187 80637 shows the area of Turbine 8. A defunct field boundary continuation is visible to the north of the

turbine location although the turbine itself appears located amongst a large curvilinear/subcircular cropmark.

6 The Field Walkover

- 6.1.1 <u>Turbine 1.</u> The area appears flat with no immediately obvious extant archaeological features. Fragments of ceramic building material were noted underfoot in the general area of the proposed turbine.
- 6.1.2 <u>Turbine 2.</u> The area appears flat with no immediately obvious extant archaeological features. Fragments of ceramic building material were noted underfoot in the general area of the proposed turbine.
- 6.1.3 <u>Turbine 3.</u> The area appears flat with no immediately obvious extant archaeological features. Fragments of ceramic building material and pottery of unknown date were noted underfoot in the general area of the proposed turbine.
- 6.1.4 <u>Turbine 4.</u> The area appears flat with no immediately obvious extant archaeological features. Fragments of ceramic building material were noted underfoot in the general area of the proposed turbine.
- 6.1.5 <u>Turbine 5.</u> The area appears flat with no immediately obvious extant archaeological features. Fragments of ceramic building material were noted underfoot in the general area of the proposed turbine.
- 6.1.6 <u>Turbine 6.</u> The area appears flat with no immediately obvious extant archaeological features. Fragments of ceramic building material were noted underfoot in the general area of the proposed turbine.
- 6.1.7 <u>Turbine 7 (A1).</u> The area appears flat with no immediately obvious extant archaeological features. Fragments of ceramic building material and pottery of unknown date were noted underfoot in the general area of the proposed turbine.
- 6.1.8 <u>Turbine 8 Plate 5.</u> The area appears flat with no immediately obvious extant archaeological features. Fragments of ceramic building material, pottery of Roman date and worked early Neolithic flint (Pannett, pers.comm) were noted underfoot in the general area of the proposed turbine.
- 6.1.9 <u>Turbine 9.</u> The area appears flat with no immediately obvious extant archaeological features. Fragments of ceramic building material, pottery, clay pipe, glass and slate were noted underfoot in the general area of the proposed turbine. This material has been ploughed into the field in recent years after a spoil heap at 'Muckhill corner' (the corner in the road to the north west of turbine 9) was largely flattened (tenant farmer, Pers. Comm.)
- 6.1.10 <u>Turbine 10.</u> The area appears flat with no immediately obvious extant archaeological features. Fragments of ceramic building material, pottery, clay pipe, glass and slate were noted underfoot in the general area of the proposed turbine. This material has been ploughed into the field in recent years after a spoil heap at 'Muckhill corner' (the corner in the road to the north west of turbine 9) was largely flattened (tenant farmer, Pers. Comm.)
- 6.1.11 <u>Turbine 11.</u> The area appears flat with no immediately obvious extant archaeological features. Fragments of ceramic building material, pottery, clay pipe, glass and slate were noted underfoot in the general area of the proposed turbine. This material has been

- ploughed into the field in recent years after a spoil heap at 'Muckhill corner' (the corner in the road to the north west of turbine 9) was largely flattened (tenant farmer, Pers. Comm.)
- 6.1.12 <u>Turbine 12 Plate 6.</u> The area appears flat with no immediately obvious extant archaeological features. Fragments of ceramic building material, pottery, clay pipe, glass and slate were noted underfoot in the general area of the proposed turbine. This material has been ploughed into the field in recent years after a spoil heap at 'Muckhill corner' (the corner in the road to the north west of turbine 9) was largely flattened (tenant farmer, Pers. Comm.)

7 Discussion and Interpretation

7.1 Reliability of Field Investigation and Desk Top Assessment

- 7.1.1 The investigation was unhampered by any modern buildings with agricultural activity proving only a small obstacle to the field investigation.
- 7.1.2 Whilst a search of finds listed in the Nottinghamshire Portable Antiquities Scheme listed many finds as being in the 'Cottam Area' no specific grid references were available. It should be noted, therefore, that although no specific examples can be cited the likelihood of small finds existing within the development area is high.

7.2 **Overall Interpretation**

- 7.2.1 The area of proposed development appears to contain features and finds from various periods with an emphasis on the Roman period. This is somewhat unsurprising given the areas proximity to the Roman town of Littleborough (*Segelocum*). Whilst the information from the Archaeology Data Service tentatively suggests a villa site (Para 4.7.4) at SK 80040 80200 & SK 80210 80800 & 80780 80020 it should be noted that no firm evidence of a villa has been observed and that the suggestion is based solely on a series of cropmarked enclosures. Further investigation would be needed in order to establish this as a villa site rather than a series of enclosures.
- 7.2.2 Medieval activity is also evidenced by the presence of cropmarked defunct field systems as well as the presence in several areas of ridge and furrow cultivation. Historic settlement cores within the villages of Cottam, South Leverton, North Leverton with Habblesthorpe as well as the Roman town of Littleborough (*Segelocum*) are likely to have been largely laid down in the Medieval period.
- 7.2.3 The majority of Post medieval activity is from the historic buildings located within the 3.5km search area. None of these, however, are located within the area of proposed development.
- 7.2.4 The area of proposed development seems to have been used for primarily agricultural purposes for at least the last 2000 years and even longer, possibly into the Iron Age.

7.3 Significance

7.3.1 The Field Walkover and Desktop Assessment have highlighted the presence of a range of archaeological features and finds in and around the area of proposed development dating primarily to the Roman, Medieval and Post Medieval periods with residual prehistoric material also present.

7.3.2 The archaeology of the proposed development area has the potential to be significant in nature. This is mainly due to the large amount of Roman activity centred around the town of Littleborough (*Segelocum*) and the associated Roman road to the north. However, given that proposed turbine and track locations can be adjusted so as to avoid archaeology a layout with a minimal impact should be sought.

8 Predicted impacts

- 8.1.1 Turbines 9 and 10 and their associated access tracks are close to several cropmarks identified by both the regional sites and monuments record and the Archaeology Data Service. Turbine 9 access track also appears to go through the field containing Spot no. 05038 (Cropmarked Enclosure, Linear feature, Ring ditch. Bronze/Iron Age) and possibly Spot no. 10 (Cropmarked Enclosures, Field System and Track way. Iron Age/Roman). The track also bisects Spot no. 05038a, a 1st 4th century Roman finds scatter.
- 8.1.2 The Turbine 8 access track also appears to run over Spot no. 15, a Cropmarked medieval field boundary and trackway. This may be the cropmark identified as being close to the location of Turbine 8 in aerial photograph Zkn-EV 122.
- 8.1.3 The field walkover also produced 3 worked prehistoric flints and 3 sherds of Roman pottery in the area of Turbine 8.
- 8.1.4 The main north south trackway to the east of Turbine 3 and the east west track to Turbine 1 appear to run in close proximity to a number of Spots marked no. 9. These are recorded by the Archaeology Data Service as various cropmarks including ditched enclosures, field systems and a trackway and are listed as being of likely Roman date.
- 8.1.5 Turbine 6 is in close proximity to Spot no. 05039a which is marked as a $2^{nd} 4^{th}$ century Roman finds scatter.
- 8.1.6 Whilst the field walkover produced finds from the area of Turbine 8 it should be noted that material of unknown date, i.e. pottery, tile and other ceramic building material was scattered over the locations of all of the turbines and access tracks.

9 **Proposals**

- 9.1.1 Given that the Desk Based Assessment has located a relatively large amount of features within the area of proposed development it is recommended that further steps be taken to ensure the preservation and recording of the archaeological resource prior to any possible development.
- 9.1.2 In the first instance it is suggested that, subject to the area not being under crop, a systematic field walking program be undertaken in order to assess the distribution of further finds and features thus enabling a more targeted approach.
- 9.1.3 A geophysical survey, again subject to the area not being under crop, could target areas directly impacted by the proposed development i.e. Turbine locations and (subject to construction method) specific areas of track.
- 9.1.4 Depending upon the results of the geophysical survey a program of intrusive field evaluation may then be undertaken within specific areas. This would enable positive identification of unknown cropmarks as either archaeological or natural features.





Fig 01: Map showing location of assessment area








Fig 4: 1796 Enclosure map of Cottam and South Leverton showing strip field patterns in the areas of Turbines 1 - 8




Fig 11: 2007 Edition Ordnance Survey map with proposed locations of Turbines overlaid in red




Plate 1: BKR 71 - Cropmarks close to Turbine 9


