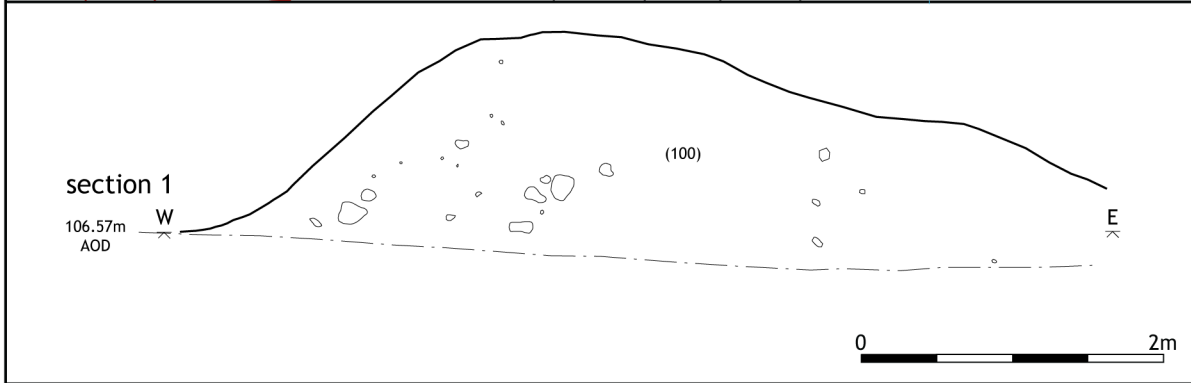
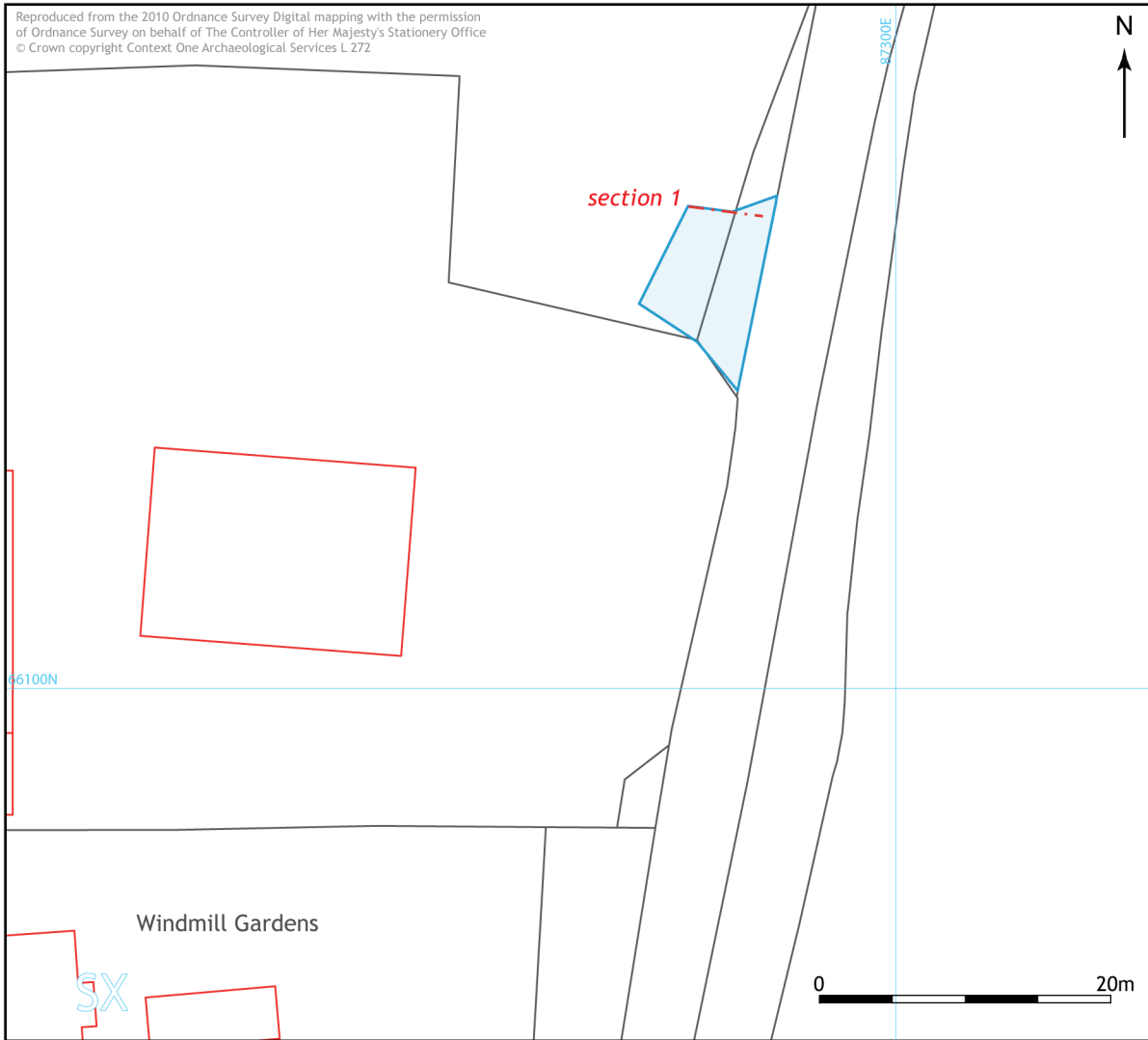

<p>Description of works.</p> <p>Context One Archaeological Services Ltd (COAS) carried out an Archaeological Watching Brief on behalf of Mr Barry Quant as a condition of granting planning permission for the creation of new farm access at Redlands Farm, Burnthouse Hill, North Whilborough, Kingskerswell (Figure 1), which involved the breaching of existing and historic hedgebanks. The request for the investigation was made by Ms Helen Rance (Archaeological Officer, Historic Environment Service (HES), Devon County Council) as the proposed development lies within an area probably first enclosed in the late medieval period and the existing hedgebanks can be observed on late 19th century mapping.</p> <p>The archaeological work involved the monitoring of all groundworks for the purpose of identifying and recording any archaeological features or deposits; however none were observed. A recorded section (Figure 1) through the breached hedgebank revealed a single soil embankment of red (10YR 2/6) silty clay soil with occasional limestone fragments (100).</p>
