#### INTRODUCTION

A watching brief on ground works for a basement extension was undertaken by York Archaeological Trust on behalf of Mrs Janet Jacobi between 13<sup>th</sup> and 14<sup>th</sup> November at 29 Gillygate, York, NGR SE 60140 52354 (Figure 1). The objective of the watching brief was to record any archaeological deposits or structures exposed by the ground works.

#### **METHODOLOGY**

A rectangular area, around 4m x 3m, located against the rear of 29 Gillygate, was stripped to a depth of 2.45m by a 1-tonne rubber-tracked excavator (Plate 1).

#### **RESULTS**

The only observable deposits were dark brown garden soil/rubble, which continued to a depth of 2.45m, a brick footing relating to the basement, and a patch of lighter brown soil seen in the east corner of the site (Plates 2-3). However, this lighter deposit was below the impact level of the ground works so was not seen in further detail.

### CONCLUSIONS

No evidence of archaeological activity pre-dating the 19<sup>th</sup> century was seen during monitoring at 29 Gillygate, York. The depth of the garden soil and rubble to 2.45m below ground level indicates that a high level of truncation and/or made ground has occurred during the construction of 29 Gillygate in the 19<sup>th</sup> century.
