# Archaeological watching brief at The Anchorage, Church Road, Clifton-upon-Teme, Worcestershire

Previous archaeological work on the site

There has been no previous archaeological work undertaken on site.

Previous archaeological work on associated sites

Clifton-upon-Teme has been the subject of a recent survey undertaken as part of the Central Marches Historic Towns Survey, which contains a summary of previous archaeological work in the village (Dalwood 1996).

The line of the original monastic boundary associated with the nearby church has been tentatively proposed on the basis of existing property boundaries, which incorporates land to the north and south of Church Road, including the present site (*ibid*; WSM 17778). Documents record the dedication of a church to St Kenelm in AD 813, although the present building dates predominantly from the 13<sup>th</sup> century, with a south aisle added in the early 14<sup>th</sup> century; restoration work in the mid 19<sup>th</sup> century; a north vestry and south porch in the 20<sup>th</sup> century (WSM 08048).

Few archaeological investigations have been undertaken within the village. Observation of drainage works within St Kenelm's churchyard revealed only modern disturbance and grave cuts (Wichbold 1993; WSM 21955).

#### Aims

The aim of the watching brief was to observe and record archaeological deposits, and to determine their extent, state of preservation, date and type, as far as reasonably possible.

Access to or visibility of structure

Observation of the excavated areas was undertaken during and after machine excavation. The exposed surfaces were sufficiently clean to observe well-differentiated archaeological deposits.

Statement of confidence

Access to, and visibility of, deposits allowed a high degree of confidence that the aims of the project have been achieved.

#### Discussion

The stratigraphy comprised a shallow turfed topsoil [1001] overlying a deeper mixed soil and clay [1002] with frequent gravel and stone fragments, in turn over natural clay and sandstone [1003]. The boundary between the mixed soil and clay was generally well-defined, indicating that the soil was not a naturally developed subsoil derived from the underlying matrix. No developed or undisturbed soil profile was observed within the foundation trenches.

A number of modern services trenches were noted, which cut into the surface of the natural. No significant archaeological features, deposits or horizons were observed.

The only finds recovered consisted of a fragment of medieval/post-medieval roof tile from [1001], of a long-lived fabric type, which was in use from the 13<sup>th</sup> to the 18<sup>th</sup> centuries. In addition two sherds of porcelain dating from the late 18<sup>th</sup> to the 20<sup>th</sup> centuries and a fragment of modern brick of 19<sup>th</sup>-20<sup>th</sup> century date were recovered from [1002]. These artefacts are of no archaeological significance, merely indicating very residual or modern material (pers comm. Alan Jacobs).

#### **Conclusions**

No significant archaeological features, deposits or horizons were observed during the project. The small artefactual assemblage is similarly insignificant, and represents residual waste disposal in medieval, post-medieval and modern contexts.

The undeveloped and disturbed nature of soil layer [1002] indicates that it is probably the result of dumping and disturbance during activity on the site within the last two hundred years, probably related to the timber yard which occupied the site until the 1970s and the construction of the present dwelling in 1985 (pers comm. Phil Haywood).

There is thus no evidence of the medieval tenement plot or any earlier activity, which was anticipated given the location opposite St Kenelm's church, which is thought to have been the site of an ecclesiastical centre or minster in the Saxon period. This cannot, however, be taken as absence of evidence generally but may simply reflect the minor scale of the present investigation.

An archaeological watching brief was undertaken on behalf of Mr and Mrs Edmonds at The Anchorage, Church Road, Clifton-upon-Teme, Worcestershire (NGR SO 7148 6156; HER ref WSM 34492). No significant archaeological features, deposits or horizons were observed. The disturbed soil profile is conjectured to be the result of activities relating to the timber yard, which previously occupied the site until the late 20<sup>th</sup> century. The small artefactual assemblage is similarly insignificant, being largely material of post-medieval date from a modern deposit.



Plate 1: north trench, sample section with a modern service duct, view south




Plate 2: south trench, sample section with modern service ducts and pipes, view south
