Previous archaeological work on the site

There has been no previous archaeological work undertaken on site.

Previous archaeological work on associated sites

Oswestry has been the subject of a recent survey undertaken as part of the Central Marches Historic Towns Survey (Dalwood and Bryant 2005) and contains a summary of previous archaeological work in the town.

Aims

Brief

The aim of the watching brief was to observe and record archaeological deposits, and to determine their extent, state of preservation, date and type, as far as reasonably possible.

Observation of the excavated areas was undertaken during and after machine excavation. The exposed surfaces were sufficiently clean to allow clear differentiation of deposits. No archaeological deposits were encountered but natural clay was observed at the base of every trench.

Statement of confidence

Access to, and visibility of, deposits allowed a high degree of confidence that the aims of the project have been achieved.

Discussion

Stratigraphy within the foundation and service trenches was comprised of modern demolition material lying above the natural clay with frequent truncation by service trenches and previous concrete footings. No significant archaeological deposits, structures or finds were present. The amount of modern truncation and disturbance suggests that archaeological features are unlikely to survive in this area.

Conclusions

No significant archaeological deposits were encountered. Natural ground was recorded at a maximum of 0.80m below ground level. All other deposits consisted of modern demolition rubble, made ground and was heavily truncated by modern services from the existing buildings surrounding the site.

An archaeological watching brief was undertaken on behalf of CgMs Ltd acting as the agent for Ross Developments Ltd at 28 Cross Street, Oswestry, Shropshire (centred at NGR 329138, 329631).Recorded deposits comprised modern demolition rubble and made ground, heavily truncated by modern services from the existing buildings surrounding the site. No archaeological deposits or features were present during the works.




