
# Archaeological Evaluation Proposed new house Inverardoch, Doune, Stirling Council

#### Introduction

This archaeological evaluation of the proposed footprint of a new house was carried out for Mr Robin Clifford and Dr Vicki Clifford to satisfy the archaeological condition on the planning consent for this development, as noted by Stirling Council Archaeology Service in the condition attached to Planning Application 11/00679/FUL/ML dated 12th December 2011. It was undertaken by the author on Friday 10th May 2012 (Site Code ARD01); weather conditions were overcast and chilly.

## Archaeological Background (Illus 1-6)

The proposed development area lies within the former grounds of Inverardoch House a now demolished mansion of 19th century date. As the proposed development lay in an area of greenfield, which had not been subject to previous development, it was felt that this meant that it had the potential to contain previously undiscovered archaeological remains from across Scotland's history and prehistory, that may have survived below the active plough-zone. The proposed development would damage or destroy such remains.

#### **Site Evaluation**

Two trenches measuring 5m by 1m (A) and 4m by 1.26m (B) respectively were opened in the proposed footprint of the house.

## Trench A (Illus 7-9)

This trench was opened on a North West-South East alignment within the footprint of the proposed house at its eastern end and was dug to a maximum depth of 1.23m below modern ground level. From modern ground level a layer of tarmac 0.10m deep over lay a compact layer of orange brown gravel and stones to a depth of 0.40m which overlay a deposit of loose yellow sand to a depth of 0.50m. These layers of deliberately laid surfaces overlay a 10cm thick deposit of light grey brown clay which may represent a former turf line (original ground surface?). Below this potential turf line a deposit of light grey sandy clay was located to the base of the trench at 1.23m. At a depth of 0.86m below modern ground level a lead water pipe was located running across this trench towards its North Western end. No finds were recovered.

# Trench B (Illus 7, 10 and 11)

This trench was opened on a North to South alignment within the proposed footprint of the house towards its western end and was dug to a maximum depth of 1.02m below modern ground level. From modern ground level a layer of tarmac 0.13m deep overlay a compact layer of grey brown gravel to a depth of 0.40 which overlay a deposit of crushed yellow sandstone and small stones to a depth of 0.87m. At the Northern end of the trench a layer of concrete was exposed at the base of the trench and at its southern end a very hard compact deposit of orange brown sandy clay and small stones was located to a depth of 1.02m below modern ground level where excavation stopped.

# Conclusions

The evaluation of the house footprint located a former ground surface and cultivated soil sealed beneath layers of laid stone surfaces associated with Inverardoch house which formerly stood to the south of the site. The top of the cultivated soil layer in Trench A included a lead water pipe at a depth of 0.86m which was presumably also associated with Inverardoch House. Trench B encountered laid stone surfaces similar to those in Trench A and a layer of concrete at a depth of 0.87m which must also be associated with Inverardoch House. No archaeological deposits of any earlier date were encountered and the results of this evaluation would suggest that there is no need for any further work on the site prior to its redevelopment.




